PHILIPPINE ASSOCIATION OF ACADEMIC AND RESEARCH  
LIBRARIES (PAARL) CONFERENCE

To: Regional Directors  
Schools Division/City Superintendents

1. The Philippine Association of Academic and Research Libraries (PAARL) will hold a three-day conference at the Four Seasons Hotel in Iloilo City on April 20-22, 2001 with the theme "Libraries as Agents of Change".
2. The participants are expected to:
  - a) be updated on the development of libraries as change agents particularly in the areas of shared leadership management, effective user services, resource allocation, collection assessment and information delivery; and
  - b) be prepared to meet the challenges of change management in the 21<sup>st</sup> century for academic, research libraries, school and public libraries.
3. Participants to this conference are librarians from both public and private elementary, secondary and tertiary schools. Participants from government/public schools are allowed to attend the conference.
4. A fee of Three Thousand Five Hundred Pesos (P3,500.00) will be charged for live-in participants or One Thousand Seven Hundred Pesos (P1,700.00) for live-out participants which includes accommodations, registration fee, seminar kit, handouts, certificate, honoraria of speakers and other expenses. Participants from the public schools are allowed to attend on official time only. Other incidental expenses relative to their attendance shall be borne by private sources, not by DECS. Those from private institutions shall make financial arrangements with their respective schools.
