ORGANIZATION OF THE COORDINATING COMMITTEE AND TECHNICAL
WORKING GROUPS TO DRAFT THE IMPLEMENTING RULES AND
REGULATIONS FOR GOVERNANCE OF BASIC
EDUCATION ACT OF 2001 (RA 9155)

1.
