PROCUREMENT OF DESKS/ARMCHAIRS UNDER SEMP

To: Undersecretaries
 Assistant Secretaries
 Regional Directors
 School Division/City Superintendents
 All Others Concerned

- 1. This Memorandum provides the procedures for the procurement of desks/chairs covered by regional and nationwide allocations for desks and chairs under the FY 2001 budget (Re-enacted) General Appropriations Act.
- 2. All Regional Offices shall submit to the Physical Facilities Division (PFD), the list of recipient schools using the attached forms and allocation per Congressional Districts under the following guidelines:
 - a) First priority will be given to schools which are recipients of new schoolbuildings/ classrooms under the CY 2001 Schoolbuilding Program and the 10% Unallocated Portion of the CY 2000.
 - b) Second priority will be given to schools with high shortages of desks and armchairs.
 - c) The computation for desk and armchairs requirement shall be 24 seats per classroom for elementary and 45 seats per classroom for secondary.
 - d) The following unit costs will be adopted:
 - Elementary School Desk (set of 1 table and 2 chairs) P1,500.00
 - Secondary School Armchair ------P 700.00
- The bidding under the desks and chairs shall be in accordance with the guidelines for the procurement of goods for World Bank-assisted projects. The bidding shall be conducted by Bids and Awards Committee (BAC) of the central office, created through DECS Order No. 29, s. 2001.
- 4. The Physical Facilities Division shall: (1) prepare the bid documents which include the final allocations list and (2) assist the SEMP-Project Management Office in the procurement and monitoring of deliveries of the desks and chairs.
