**REGISTRATION FOR SANGGUNIANG KABATAAN ELECTIONS**

To: Regional Directors  
Schools Division/City Superintendents  
Private Secondary Schools Principals

1. The Sangguniang Kabataan elections on May 6, 2002 will be a vital exercise by the youth, of their right of suffrage. As such, it is of paramount importance that they must be made aware of what they must do in order to be able to exercise their right. Most especially, they must be informed of the need to register.
2. In this regard, all heads of public and private secondary schools are advised to inform their students that the registration for the SK polls shall be from December 10-26, 2001, for the youth, 15-21 years old during regular office hours at the Office of the Election Officer of the city or municipality where the applicant resides.
3. The registration of voters for the regular elections, under the continuing system of registration will also end on December 26, 2001. Enclosed are primers on the Registration of Voters for the Sangguniang Kabataan Elections and the Frequently Asked Questions on the Continuing Registration of Voters.
4. Immediate dissemination of this Memorandum is desired.

ELECTIONS BE HELD?**

**May 6, 2002 - 7:00 AM until 3:00 PM**

**WHO SHALL VOTE FOR THE SK ELECTIONS?**

MEMBERS OF THE *KATIPUNAN NG KABATAAN*

**WHAT IS THE *KATIPUNAN NG KABATAAN (KK)*?**

It is the assembly of youth in the barangay who are 15 to 21 years of age.

**HOW CAN ONE BECOME A MEMBER OF THE KK?**

By filing an application for registration as member of the Katipunan ng Kabataan with the Office of the Election Officer of the city/municipality where one resides. If one's application is approved, he/she becomes a member of said Katipunan.

## **WHO ARE QUALIFIED TO REGISTER?**

Those who are:

1. Filipino citizens;
2. At least fifteen (15) but not more than twenty-one (21) years of age, born on any day from May 6, 1981 to May 6, 1987;
3. Actually residing in the barangay for at least six (6) months on election day; and
4. Not otherwise disqualified by law.

## **WHO ARE DISQUALIFIED TO REGISTER?**

1. Those sentenced by final judgment to suffer imprisonment of not less than one (1) year;
2. Those adjudged by final judgment of having committed any crime involving disloyalty to the duly constituted government; and
3. Insane or incompetent persons as declared by competent authority.

## **REGISTRATION POLICY AS PER COMELEC RES. NO. 4713:**

1. Those who are fifteen (15) but below eighteen (18) years of age shall register;
2. Those who are eighteen (18) but not more than twenty-one (21) years of age who are not yet registered as voters for regular elections shall register under the system of continuing registration;
3. Those who are eighteen (18) but not more than twenty-one (21) years of age who are registered voters under the system of continuing registration need not register as they are automatically considered as registered members of the *Katipunan ng Kabataan*.

## **WHERE WILL THE YOUTHS FILE THEIR APPLICATIONS FOR REGISTRATION AS MEMBER OF THE KK?**

In the Office of the City/Municipal Election Officer, Monday to Saturday from 8:00 AM to 5:00 PM.

## **WHEN IS THE FILING OF APPLICATIONS FOR REGISTRATION OF VOTERS FOR THE SK ELECTIONS?**

December 10, 2001 until December 26, 2001

## **PROCEDURE FOR REGISTRATION TO QUALIFY AS VOTER FOR THE MAY 6, 2002 SK ELECTIONS:**

- Go personally to the office of the Election Officer in your city/municipality any day during office hours (Mondays to Saturdays from 8:00 am to 5:00 pm);
- Bring any of the following for identification:
  1. Certificate of Live Birth;
  2. Baptismal Certificate;
  3. School records;
  4. any other documents that will establish your identity and qualification **except** Barangay Certification or Community Tax Certificate (CEDULA).
- Personally accomplish the application form in two (2) copies in your own handwriting and in the presence of the EO;
- Affix your three (3) specimen signatures on each copy; and
- Affix clear and legible imprints of your right and left thumbprints on each copy.

RESOLUTION NO. 4713

**WHEREAS**, Article 202, Rule XXVII of the Rules and Regulations Implementing the Local Government Code of 1991 provides for an assembly of youth in every barangay to be known as Katipunan ng Kabataan whose primary objective is to enhance the social, political, economic, cultural, intellectual, moral, spiritual, and physical development of the youth of the country;

**WHEREAS**, Article 203 of the same Rule provides that the Katipunan ng Kabataan of each barangay shall elect its Sangguniang Kabataan composed of a chairman and seven members;

**NOW, THEREFORE**, the Commission on Elections, by virtue of the powers vested in it by the Constitution of the Republic of the Philippines, Republic Acts No. 7160, 7808, the Omnibus Election Code and other election laws, **RESOLVED** to promulgate, as it hereby promulgates, the following rules and regulations to govern the conduct of registration of members of the Katipunan ng Kabataan for purposes of the May 06, 2002 election of members of the Sangguniang Kabataan:

**Section 1. Registration policy.** - Applicants for registration as members of the *Katipunan ng Kabataan* shall be registered as follows:

who are fifteen (15) but below eighteen (18) years of age shall register

- b) Those who are eighteen (18) but not more than twenty one (21) years of age who are not yet registered as voters for regular elections shall register under the system of continuing registration;
- c) Those who are eighteen (18) but not more than twenty one (21) years of age who are registered voters under the system of continuing registration need not register as they are automatically considered as registered members of the *Katipunan ng Kabataan*.

**SEC. 2.** *Date, time and place of filing and hearing of applications for registration* - The applications for registration as members of the *Katipunan ng Kabataan* shall be filed and heard during regular office hours at the Office of the Election Officer of the city/municipality where the applicant resides, in accordance with the following schedule:

**SEC. 3.** *Who may be registered as members of the Katipunan ng Kabataan.* - Any Filipino citizen who is:

- a) At least fifteen (15) but not more than twenty one (21) years of age, that is, born on any day from May 05, 1981 to May 06, 1987;
- b) Actually residing in the barangay for at least six (6) months on election day.
- c) Not otherwise disqualified by law.

**SEC 4.** *Who are disqualified to register.* - The following are disqualified to register as members of the *Katipunan ng Kabataan*:

- a) Any person who has been sentenced by final judgment to suffer imprisonment



reacquire the right to vote upon the expiration of five (5) years after service of sentence;

- b) Any person who has been adjudged by final judgment of a competent court or tribunal of having committed any crime involving disloyalty to the duly constituted government, such as rebellion, sedition, violation of the firearms laws, or any crime against national security, as defined and penalized under the Revised Penal Code. However, he shall automatically regain his right to vote upon the expiration of five (5) years after service of sentence; and
- c) Insane or incompetent persons as declared by competent authority.

**SEC. 5.** *Procedure for filing of applications for registration.* - The filing of applications for registration shall proceed as follows:

- a) The applicant shall personally appear before the Election Officer of the city/municipality where he resides, state his name and exact address, specifying the house number, name of the street, area, district, *purok* or *sitio* and barangay where he resides, or a brief description of his residence, and present any of the following documents:

1. Certificate of Live Birth;
2. Baptismal Certificate;
3. School records; or
4. Any other documents that will establish his identity and qualification.

*Community Tax Certificate and certifications of barangay officials shall not be honored.*

- b) In the absence of the above documents, another voter may, under oath, identify the applicant. However, no voter shall be allowed to identify more than three (3) applicants unless they are immediate members of his family.
- c) The Election Officer shall then determine if the applicant resides within the

If so, the Election Officer shall explain to him the qualifications and disqualifications for registration, including the policy of the Commission as stated in Section 1 hereof.

In addition, the Election Officer shall inform the applicant of the name(s) and location(s) of existing voting center(s) in the barangay, and require him to write in any available space of the application form, the name and location of the voting center that is nearest and most accessible to his residence.

- d) Thereafter, the Election Officer shall record in a logbook the applicant's name and the serial number of the application form given to him and forthwith issues the application form in two (2) copies to the applicant;
- e) Upon receipt of the application form, the applicant shall accomplish the two (2) copies individually in his own handwriting and in the presence of the Election Officer. The use of carbon paper shall not be allowed;
- f) The Election Officer shall guide the applicant on how to accomplish the application form to ensure that all entries therein are complete, legibly written and that:
  1. The three (3) specimen signatures of the applicant are properly affixed on each copy;
  2. The rolled imprints of his left and right thumbs are clearly and distinctly impressed.  
  
In case the applicant's thumbprints are blurred, smudged or faint, they shall be retaken on any available space of the application form. If the applicant refuses to have his thumbprints retaken, his accomplished application form shall be rejected by the Election Officer and marked as such accordingly. The applicant shall be informed that such rejection is equivalent to non-registration; and
  3. The name and location of the voting center nearest and most accessible

relative within the fourth civil degree of consanguinity or affinity or any member of an accredited citizens arm in accordance with the provisions of Republic Act No. 8189 as implemented by Comelec Resolution No. 2904 dated March 14, 1997.

- h. After accomplishing the two (2) copies of the application form, the applicant shall return the same to the Election Officer who shall verify whether or not it is the same set given by comparing its serial number with the recorded serial number of the application earlier issued and if so, examine the completeness of the data written therein.

Any application form submitted by an applicant with a serial number different from that recorded shall be invalidated and marked with the word "REJECTED" written diagonally across the two (2) copies. Such rejected copies shall then be placed in the envelope for spoiled registration records and the applicant given another set of application, without prejudice, however, to the filing of appropriate charges, if warranted.

**SEC. 6. *Notice of hearing of application.*** - Upon receipt of the application, the Election Officer shall immediately set them for hearing in accordance with the schedule shown in Section 2 hereof, notices of which shall be posted in the city/municipal bulletin board and in his office, furnishing copies thereof to the applicants concerned and other accredited groups or organization in the city/municipality.

**SEC. 7. *Challenge of right to register.*** - Any Katipunan ng Kabataan member may challenge in writing and under oath any application for registration, stating the ground for the challenge. The challenge shall be filed at the Office of the Election Officer within the time provided under Section 2 hereof.

In case of challenge, the Election Officer shall immediately notify the applicant of the challenge and require the applicant to be present during the hearing so that he can rebut or refute the evidence against his application. The challenge shall be attached to the application, together

**Section 8.** *Approval or disapproval of application.* - The Election Registration Board constituted under Republic Act No. 8189 as implemented by Comelec Resolution No. 2904 dated March 14, 1997, shall act on all applications for registration and shall, by majority vote, approve or disapprove the applications in accordance with the schedule stated in Section 2 hereof.

In case of approval, any aggrieved party may file a petition for exclusion with the proper municipal or municipal circuit or metropolitan trial court not later than January 25, 2002.

In case of disapproval, the aggrieved party may file with the proper municipal or municipal circuit or metropolitan trial court a petition for inclusion not later than January 18, 2002.

If the Board disapproves the application, the applicant shall be furnished with a certificate of disapproval stating the ground or grounds for the disapproval.

**SEC. 9.** *Publication of action on application for registration.* - Immediately after the approval or disapproval of an application for registration, the Board shall post a notice in the bulletin board of the municipal hall and in the office of the Election Officer, stating the names and addresses of the applicants, the dates of the applications and the actions taken thereon.

**SEC.10.** *Preparation of the list of Katipunan ng Kabataan members.* -- After the meeting of the Election Registration Board on January 04, 2002, the Election Officer shall immediately compile all the approved applications for registration (copy for the Election Officer) by barangay, then segregate the barangay compilation according to the voting centers as indicated in the approved application for registration and arrange the approved applications alphabetically by voting centers.

Thereafter, the Election Officer shall extract from the Computerized Voters List the names of voters aged 18 to 21 as of May 06, 2002, indicate their voting centers as of the last election, and include their names in the *Katipunan ng Kabataan* members with the same voting centers. The extract shall include the names of voters 18 to 21 years whose applications were approved in the January 9, 2002 hearing of the Election Registration Board.

Based on the combined list, the Election Officer shall prepare a list of voters with voting records with the names arranged alphabetically by precinct at the rate of four hundred (400) voters per precinct.

There shall be at least one precinct in every barangay.

**SEC. 11. Numbering of precincts.** – The precincts established herein shall be indicated by the initials “SK” followed by the Arabic numeral beginning with the figure “1”. The numbering shall start in the barangay in a city or municipality that is first alphabetically and continue up to the last barangay that is last alphabetically in the same city or municipality.

In cities/municipalities where all barangays are numerically denominated, they shall be numbered starting from lowest to highest. In cities/municipalities where some barangays are numerically denominated and some barangays by name, the precincts shall be numbered in accordance with the alphabetical rule first followed by the numerical rule.

In the case of cities consisting of two or more legislative districts, or cities and municipalities divided into two or more councilor districts, the numbering shall start from the barangay which is first alphabetically in a district and continue up to the barangay which is last alphabetically in the same district.

Thereafter, the Election Officer shall extract from the Computerized Voters List the names of voters aged 18 to 21 as of May 06, 2002, indicate their voting centers as of the last election, and include their names in the *Katipunan ng Kabataan* members with the same voting centers. The extract shall include the names of voters 18 to 21 years whose applications were approved in the January 9, 2002 hearing of the Election Registration Board.

Based on the combined list, the Election Officer shall prepare a list of voters with voting records with the names arranged alphabetically by precinct at the rate of four hundred (400) voters per precinct.

There shall be at least one precinct in every barangay.

**SEC. 11. Numbering of precincts.** – The precincts established herein shall be indicated by the initials “SK” followed by the Arabic numeral beginning with the figure “1”. The numbering shall start in the barangay in a city or municipality that is first alphabetically and continue up to the last barangay that is last alphabetically in the same city or municipality:

In cities/municipalities where all barangays are numerically denominated, they shall be numbered starting from lowest to highest. In cities/municipalities where some barangays are numerically denominated and some barangays by name, the precincts shall be numbered in accordance with the alphabetical rule first followed by the numerical rule.

In the case of cities consisting of two or more legislative districts, or cities and municipalities divided into two or more councilor districts, the numbering shall start from the barangay which is first alphabetically in a district and continue up to the barangay which is last alphabetically in the same district.

**SEC. 13.** *Voters excluded through inadvertence or registered with an erroneous or misspelled name.* - Any registered voter whose approved registration record has not been included in the list of voters or who has been included therein with a wrong or misspelled name may file with the Board an application for inclusion of his record, or reinstatement or correction of his name as the case may be. If it is denied or not acted upon, the voter may file on any date with the proper Municipal or Municipal Circuit or Metropolitan Trial Court a petition for an order directing that the voter's name be entered or corrected in the list. The voter shall attach to the petition a certified true copy of his registration record or identification card or the entry of his name in the list of voters, together with proof that his application for inclusion of his record or reinstatement or correction of name, as the case may be, was denied or not acted upon by the Board and that he has served notice thereof to the Board.

**SEC. 14.** *Petition for inclusion of voters.* - Any person whose application for registration has been disapproved by the Election Registration Board or whose name has been stricken out from the list may, not later than January 18, 2002, file with the municipal/metropolitan trial court concerned, a sworn petition for the inclusion of his name in the list of voters for the *Sangguniang Kabataan* elections.


**SEC. 15.** *Petition for exclusion of voters.* - Any registered voter may, not later than January 25, 2002, file with the proper municipal/metropolitan trial court, a sworn petition for the exclusion of a registered voter in the list of voters for the *Sangguniang Kabataan* elections.

**SEC. 16.** *Posting of the certified and final list of voters.* - The Board shall, on or before February 05, 2002, post the certified and final list of voters for the *Sangguniang Kabataan* elections at the at the Office of the Election Officer and in the bulletin boards of each barangay concerned.

**SEC. 17.** *Effectivity.* - This Resolution shall take effect seven (7) days after its

**SEC. 18. Publication and dissemination.** - The Education and Information Department is directed to cause the widest dissemination of this Resolution and its publication in two (2) newspapers of general circulation in the Philippines.
