**TRAINING PROGRAM ON THE IMPLEMENTATION OF THE 2002 BASIC
EDUCATION CURRICULUM REFORM**

To : Bureau Directors
Regional Directors
Schools Division Superintendents
Heads of Units/Centers

1. The Department of Education (DepEd) through the Curriculum Reform Committee will conduct a 3-day Training Program for Regional Directors and Schools Division Superintendents on the Implementation of the 2002 Basic Education Curriculum (BEC) Reform on March 6-8, 2002 at Teachers Camp, Baguio City.
2. The Training Program aims to equip the participants with information, skills, and attitudes necessary for the successful implementation of the 2002 BEC. In particular, the training program will: a) present the rationale, features, and implementing guidelines/procedures for the 2002 Basic Education Curriculum; b) discuss relevant integration approaches, teaching methodologies, prototype lesson plans and sample schemes for school/class programming, teacher loading, and pupil/student evaluation; c) promote a positive attitude among all teachers and administrators regarding the 2002 BEC; and d) finalize training and implementation plans for the 2002 BEC at the school level.
3. The participants to the Training Program are all Regional Directors (RD), Assistant Regional Directors (ARD), Chiefs of Elementary Education Division (EED) and Secondary Education Division (SED), as well as all Schools Division Superintendents (SDS) and Assistant Schools Division Superintendents (ASDS: 1 for Elementary and 1 for Secondary where applicable) who will head the Division Training Teams for the Training of Teachers, School Administrators, and Division and District Supervisors in their respective areas. The Regional Offices are requested to submit the list of participants from their respective Regions and Divisions on or before March 1, 2002 to the National Educators Academy of the Philippines (NEAP) at facsimile numbers: (02) 633-72-37/ (02) 638-86-38.

4. Expenses for supplies and materials, training kits, board and lodging of participants, resource persons, facilitators and staff, professional fees of resource persons, travel expenses of resource persons, facilitators and staff, transport of training materials, overtime pay of facilitators and staff, rental of equipment and workshop rooms and other incidental expenses are chargeable against the 2002 Basic Education Curriculum Reform Funds (OSEC Funds), while transportation of participants and other incidental expenses are chargeable against local funds, subject to the usual accounting and auditing rules and regulations.

5. Immediate and wide dissemination of this memorandum is desired.
