TWENTY SECOND NATIONAL SECONDARY SCHOOL ADMINISTRATORS CONGRESS

To: Bureau Directors

- 1. The Philippine Association of Secondary School Administrators (PASSA), in collaboration with the Bureau of Secondary Education, announces the holding of a National Secondary School Administrators Congress at Teachers Camp, Baguio City on March 10 to 14, 2002. The theme of the congress is "The Principal at the Helm of Education Reform" (Giving Meaning to Management, Administration and Leadership).
- 2. The objectives of the congress are as follows: a) to enable the administrators to interrelate the vision of secondary education with curriculum teacher development and student learning, b) to derive implications of these interrelations on their day-to-day office of school management and administration, and most important, c) to arrive at a working plan for the implementation of the curriculum reform and peer accreditation.
- 3. Participants to this congress are private and public secondary school principals, administrators, superintendents and assistant superintendents in charge of secondary education, heads of secondary trade-agriculture-fisheries schools, and teachers-in-charge of public secondary schools. Attendance to this conference shall be on official business.
- 4. For the Workshop on the RESTRUCTURED INTEGRATED CURRICULUM, particularly MAKABAYAN (the fifth learning area), participants are advised to bring data for the following expected outputs:
 - 1. Teacher Load
 - 2. Grading System
 - Class Program
- 5. Members of the different committees shall be considered participants and shall pay the conference fee and are authorized to travel two days before the congress.
