**SUMMER ACTIVITIES OF SCHOOL HEALTH AND
NUTRITION PERSONNEL**

To: Regional Directors
Schools Division Superintendents

1. During the summer months of April and May, all school health and nutrition personnel are expected to undertake the following activities:

- a. conduct health profiling (history taking) and health examination of teachers and non-teaching personnel;
- b. health examination of Grade I entrants during the enrolment days starting May 27, 2002
- c. in-service training on health and nutrition procedures/updates;
- d. orientation of school principals on the Integrated School Health and Nutrition Program;
- e. monitoring of compliance to treatment of teachers and non-teaching personnel found positive for tuberculosis;
- f. monitoring of beneficiaries of food commodities like liquid/powdered milk or iron fortified noodles to check whether these have been consumed on or before end of classes;
- g. preparation of proposals for sourcing of additional funds from GOs, LGUs and NGOs;
- h. consolidation/submission of reports particularly the nutritional status after the feeding program and the year-end consolidated nutritional status;
- i. planning the scope of work for SY 2002-2003;
- j. completion of data bank for SY 2001-2002; and
- k. upkeep of the office of the Health and Nutrition Unit/Section;

2. The Regional Health and Nutrition Unit Staff are likewise expected to conduct mobilization/social preparation activities for the effective implementation of the Program in all divisions; more particularly in the pilot areas of the Comprehensive School Health and Nutrition Service Package. Funds for traveling expenses of the health personnel for the summer activities shall be transferred to the regional offices. Year-end reports on nutritional status of elementary and secondary students shall be submitted on or before April 15, 2002
