**ADMINISTRATION OF THE YEAR 2002 LICENSURE EXAMINATION  
FOR TEACHERS (L.E.T.)**

1. The Professional Regulation Commission and the Board for Professional Teachers will administer the Year 2002 Licensure Examination for Teachers (L.E.T.), both public and private elementary and secondary levels on August 25, 2002 in seventeen (17) regional provincial testing centers nationwide.
2. Applications may be filed at the PRC Main Office, PRC Regional Offices in Baguio, Cagayan de Oro, Cebu, Davao, Iloilo, Legazpi, Lucena, Tacloban, Tuguegarao and Zamboanga cities from February 1 to May 31, 2002, and at the DepEd Regional Educational Learning Centers/Division Offices in Angeles and Ozamis cities from May 20 to May 31, 2002; Dagupan and General Santos cities from May 23 to May 31, 2002; Butuan and Cotabato cities from May 25 to May 31, 2002.
3. Regional Directors concerned through the Schools Superintendents in places where the DepEd Division Offices or the Regional Educational Learning Centers (RELCs) will be the filing centers are enjoined to provide a room or space for the PRC Teams where they will temporarily hold office and receive applications, and to make available their computers and printers, dormitories or home economics building to house or accommodate the teams during the application and examination periods.
4. All Regional Directors and Schools Superintendents are also enjoined to make available selected public school buildings and facilities as venues of examinations as well as the services of school teachers and other DepEd personnel needed as examination supervisors and room watchers/proctors during the actual conduct of the examination on August 25, 2002. Enclosed is the PRC official announcement.

11. Biological Sciences (Biology, Environmental Science)
12. Physical Science (General Science, Chemistry, Physics)

The following are the application requirements:

- (1) Duly accomplished PRC Application Form and Permanent Examination and Registration Record Card;
- (2) Original and photo-copy or authenticated copy of the Transcript of Records with Special Order Number;
- (3) Original and photo-copy or authenticated copy of the Certificate of Birth or Record of Birth;
- (4) 3 identical copies of passport-size close-up picture with complete name printed; and
- (5) Stamped-window mailing envelope worth not less than P5.00.

EXAMINATION FEE is P600.00

**APPLICANTS WHOSE NAMES ARE NOT THE SAME WITH THE NAMES APPEARING IN THE BIRTH CERTIFICATES AND TRANSCRIPT OF RECORDS SHALL NOT BE ACCEPTED. THEY WILL BE ADMITTED ONLY UPON SUBMISSION OF AMENDED BIRTH CERTIFICATE FROM THE NATIONAL STATISTICS OFFICE (N.S.O.) OR LOCAL CIVIL REGISTRAR AND CORRECTED TRANSCRIPT OF RECORDS DURING THE APPLICATION PERIOD.**
