**TRAINING OF TEACHER TRAINORS FOR THE
SPECIAL PROGRAM FOR THE ARTS**

To: Regional Directors
Schools Division Superintendents
Secondary School Principals

1. The Department of Education (DepEd), through the Bureau of Secondary Education (BSE), in cooperation with the Philippine High School for the Arts (PHSA), Dalubhasaan sa Edukasyon ng Sining at Kultura (DESK) and the Cultural Center of the Philippines, shall conduct a Teacher Trainors' Training Workshop for the Arts in preparation for the third year pilot implementation of the Special Program for the Arts (SPA) for School Year 2002 - 2003.
2. The Workshop, which shall be held on May 27 - June 7, 2002 at Teachers Camp, Baguio City, aims to enhance the competencies of teacher trainors in developing the talents of artistically inclined students from selected pilot schools, and in preparing the syllabus and prototype lessons in their specific areas.
3. Participants in the training workshop are teachers, principals/school coordinators of the pilot schools for the SPA and SPA regional coordinators. Each pilot school shall send eight teacher participants for the training: one each for Vocal Music, for instrumental music, Visual Arts, Theater Arts, Media Arts, Dance, and two for Creative Writing, (English and Filipino).
4. Transportation expenses shall be charged against local funds. The board and lodging of teacher participants shall be charged against BSE funds, while the board and lodging of principals/school coordinators and regional coordinators shall be charged against local funds. Traveling expenses, per diems, board and lodging and other incidental expenses of BSE personnel shall be charged against BSE funds. These expenses are subject to the usual accounting and auditing rules and regulations.
5. Full cooperation of all concerned is enjoined and immediate dissemination of this Memorandum is desired.
