2002 NATIONAL OBSERVANCE OF DEAF AWARENESS WEEK

To: Bureau Directors

Heads of Public and Private Special Schools/Centers

- 1. Pursuant to Presidential Proclamation No. 829 dated November 8, 1991, the 2002 National Deaf Awareness Week will be observed on November 9-15, 2002. The theme of the celebration is "Empowerment, Abilities, and Recognition (EAR) of the Deaf."
- 2. All schools with Special Education (SPED) programs for the deaf are enjoined to participate in any or all of the following activities:
 - a. hearing evaluation of all students (Inclosure No. 1 List of Schools/Agencies to Conduct Free Hearing Evaluation);
 - b. workshop on theater arts, song interpretation and choreography;
 - c. on the spot painting and academic contests;
 - d. arts and crafts exhibits and camping;
 - e. symposia on parenting the deaf advocacy and involvement; and
 - f. other related activities the schools may undertake
- 3. In order not to disrupt classes, the celebration should be made part of the regular classroom activities to maximize time for learning. This is consistent with DepEd Order No. 20 s. 2002
- 4. Heads of aforementioned schools are likewise encouraged to invite other agencies and organizations providing services to the deaf to join the celebration.
- Immediate and wide dissemination of this Memorandum is desired.
