- 1. The Philippine Association of Education Supervisors (PAES) will hold a 2-Day Live-out Convention at the Traders Hotel, Roxas Blvd., Manila on September 26-27, 2002 with the PAES-NCR Chapter taking the initiative. Its theme is "Modernizing Instructional Supervision in the Light of 2002 BEC".
- 2. The PAES Convention aims to upgrade the supervisory skills and competencies of the education supervisors to ensure effective and successful implementation of the 2002 Basic Education Curriculum. It shall be organized in collaboration with the National Educators Academy of the Philippines (NEAP) under the Department of Education which shall provide guidance in the planning of the substantive content of the technical sessions.
- 3. Participants to the convention are division and regional supervisors from the sixteen (16) regions.
