# NATIONAL SCHOOLS PRESS CONFERENCE (NSPC) FOR SY 2002-2003

To : Bureau Directors

Regional Directors

Schools Division/City Superintendents

- 1. As a culminating activity of the Campus Journalism Program for SY 2002-2003, the National Schools Press Conference (NSPC) shall be held on February 24-27, 2003 at Lapu-Lapu City and Mandaue City, Region VII.
- 2. As adopted in this year's RSPC, the theme of the national conference is "Expanding the Reach of Campus Journalism through Information and Communication Technology" (Pagpapalawak ng Saklaw ng Pampaaralang Pamamahayag sa Pamamagitan ng Teknolohiya sa Impormasyon at Komunikasyon). The 2002-2003 NSPC aims to:
  - a. broaden the students' competencies in journalism through the application of information and communication technology;
  - b. enrich the experiences and enhance the skills of student-writers and teacher-advisers through friendly journalistic competition; and
  - c. hone the mentoring/coaching abilities of school paper advisers in desktop publishing and radio broadcasting.
- 3. The main participants in the NSPC are the TWO THOUSAND SIX HUNDRED EIGHTY EIGHT (2,688) RSPC winners of the individual writing contests both in English and Filipino at the elementary and secondary levels. The other participants who shall compose the regional delegations are listed in the Inclosure.
- 4. The host region for the NSPC shall receive a subsidy of THREE MILLION PESOS (3,000.000.00). A minimal registration fee of TWO THOUSAND PESOS (2,000.00) per participant to augment existing funds shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
- 5. Participants from private schools should make the necessary arrangements with their respective institutions for their participation in the NSPC.

- 6. Those regions with pupil/student participants with special needs shall make appropriate arrangements with the host region.
- 7. The Implementing Guidelines for the conduct of the NSPC and its related activities are appended as Inclosure to this Memorandum.

# IMPLEMENTING GUIDELINES FOR THE CONDUCT OF THE NATIONAL SCHOOLS PRESS CONFERENCE (NSPC), SY 2002-2003

#### **General Guidelines**

#### Travel Arrangements

a. The head of the regional delegation shall be responsible for his/her delegation's travel arrangements to and from the contest site and during the NSPC activities.

d,

- b. The list of members of regional delegation, certified by the Regional Director, with the males separated from the females, shall be sent not later than January 15, 2003 to the Director of Region VII, Cebu City, copy furnished
  - 1. The Director IV, Bureau of Elementary Education
  - 2. The Director III, In-Charge of BSE
  - 3. The Schools Division Superintendent, Lapu-Lapu City
- c. Information about the means of transportation, date and time of arrival of the regional delegation shall be provided the host region at least two (2) weeks before the date of arrival.

#### Registration Schedule, Fees and Other Registration Arrangements

- a. Each delegate to the NSPC shall be charged a registration fee of **TWO THOUSAND PESOS** (2,000.00) payable to the host region, for a four (4)-day conference that shall start on February 24 and shall end on February 27. The first meal (lunch) shall be served on February 24 and the last meal (morning snack) on February 28.
- b. Regional participants are required to register with the Registration Committee by presenting their school identification cards (I.D.), a medical certificate issued by a government physician and a copy of parent's permit. The Registration Committee is under strict instructions not to accept registrants without these necessary documents.
- c. The Registration Committee shall receive from each Regional Editors' Guild President and Regional Advisers' Association President (elementary and secondary) the total collection of the membership fees in their respective regions within the duration of the NSPC.
- d. The collection shall be turned over to the respective treasurers of the national associations (PAESPA, NSSPAA) and the National Editors' Guild for Elementary and Secondary.

# Contest Rules

- a. Contestants are not allowed to use cellular/mobile phones and the like during the contest proper.
- b. Substitution of regional winners or contestants shall not be allowed in the NSPC proper, although a teacher-adviser replacement is allowed for an adviser who cannot participate in the NSPC, for as long as the number of regional delegation is maintained.
- c. Participants in photojournalism may use cameras of their choice. Sophisticated cameras (with zoom lens, wide angle, telephoto and the like) may be allowed except for digital camera. Films shall be made available to the participants for free a few minutes before the contest.
- d. Participants are required to be at the testing centers on time. A waiting/holding area for contestants and advisers shall be provided within the compound of the testing center.

#### OTHER NSPC RELATED ACTIVITIES

The Search for the Outstanding Elementary and Secondary School Paper Advisers and the Outstanding Elementary and Secondary Campus Journalists of the Philippines for SY 2002-2003 shall continue to be a part of this year's conference. (DECS Memorandum No. 453, s. 2000.)
