# LEGAL ASSESSMENT AND PLANNING ACTIVITY FOR 2003

To: Regional Directors

- 1. The Department of Education (DepEd), through the Office of the Undersecretary for Legal Affairs, will conduct a workshop on Legal Assessment and Planning Activity for 2003 involving central and regional legal officers/personnel. This will be a two-day activity on a live-in basis which will be held on January 30-31, 2003 at Mt. Makiling Highland, Makiling, Laguna.
- 2. The workshop aims to improve/upgrade the delivery of legal service of this Department. Specifically, the objectives of this workshop are the following:
  - a. To discuss the problems encountered which hamper the delivery of an efficient and quality legal service; and
  - b. To come up with a list of projects/activities to be undertaken for the year 2003 and to adopt strategies for their efficient and effective implementation.
- 3. The Regional Director (RD) shall be responsible for selecting representative and participants to this workshop and their names shall be submitted to the Office of the Undersecretary for Legal Affairs before January 20, 2003.
- 4. Resource speakers from the Civil Service Commission (CSC), Ombudsman, and Commission on Audit (COA) have been invited to enhance the skills and competence of the legal staff. Please see enclosure for Program of Activities of the said workshop.
- All expenses incurred by the participants of this workshop such as registration fee and travel expenses shall be charged against local funds subject to usual accounting and auditing rules and regulations. Moreover, all other expenses relative to this activity such as professional fees, supplies, transportation of resource persons and facilitators shall be charged against OSEC funds. Furthermore, Mrs. Mayumi H. Tomelden, Disbursing Officer II, Cash Division, is hereby authorized as Disbursing Officer for this activity.
