**TWENTY-THIRD NATIONAL SECONDARY SCHOOL ADMINISTRATORS
CONGRESS**

To: Bureau Directors
Regional Directors
Schools Superintendent/City Superintendents
Private and Public Secondary School Principals
Vocational High School Principals

1. The Philippine Association of Secondary School Administrators (PASSA), in collaboration with the Bureau of Secondary Education, announces the holding of the National Secondary School Administrators Congress at Teachers Camp, Baguio City on March 2 to 6, 2003. The theme of the congress is "***Building a Constituency To Make Education Work***" (*Leading the Synergy of Basic Education Stakeholders*).
2. The congress will focus on the human elements of the school and the dynamics of the Office of the Principal in building them into a solid constituency. Hence, the congress seeks to provide high school principals with a) an appreciation of the dynamic relationship among their office, the teachers, the parents and the students in building a constituency towards a workable education delivery system; b) a better hold of the respective perspectives and motivations of teachers, parents, and students towards their more effective synergy; and c) an appreciation of the issues facing school governance.
3. Participants to this congress are private and public secondary school principals, administrators, superintendents and assistant superintendents in charge of secondary education, chiefs or assistant chiefs of Secondary Education Division, heads of secondary trade-agriculture-fisheries schools, and teachers-in-charge of public secondary schools. Regional/division supervisors in charge of secondary education are also invited to attend the congress. *Q*

4. A registration fee of Four Thousand Five Hundred Pesos (P4,500.00) shall be charged each participant and committee members to cover expenses for board and lodging, conference materials and kits, etc. Attendance to this congress shall be on official business.
5. Members of the different committees shall be considered participants and shall pay the registration fee and are authorized to travel two days before the congress.
