READING PROGRAM SUMMER WORKSHOP

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Elementary Schools

1. The *Sa Aklat Sisikat (SAS)* Foundation, Inc. in partnership with the Coca-Cola Foundation, Philippines, Inc. (CCFPI) and in coordination with the Bureau of Elementary Education (BEE), will hold the CCFPI-SAS Reading Program Summer Workshop on May 23-26, 2003 at the Great Eastern Hotel, #1403 Quezon Avenue, Quezon City.
2. The program aims to develop the love of books and the habit of reading among Filipino children.
3. Moreover, under the program, combination classes in the first 20 beneficiary schools of the Little Red School House Project (see enclosed list) shall hold a month-long Read-A-Thon. During the Read-A-Thon, Grades 3 and 4 pupils are allowed an hour a day for reading various materials other than their textbooks. Notable Philippine literary children's books in English and Filipino and class reading progress charts will be provided to the pupils and teachers. The Read-A-Thon will culminate in a festive celebration where the pupils creatively interpret the stories they have read.
4. The participants to the summer workshop are the teachers and school heads of the beneficiary schools. Each beneficiary school is requested to submit the names of the participants on or before March 21, 2003 to the CCFPI office at the 23rd Floor, San Miguel Properties Center (SMPC), #7 St. Francis Street, Ortigas Center, Mandaluyong City c/o Ms. Tina Lagbao at tel. nos. (02) 688-58-63 to 64, and fax no. 631-86-75. Enclosed is the guidelines for the summer workshop.
5. All travelling expenses incurred based on the shortest/direct route at the most economical rates prevailing in the area shall be reimbursed by the CCFPI upon presentation of receipts.
6. Immediate and wide dissemination of this Memorandum is desired.

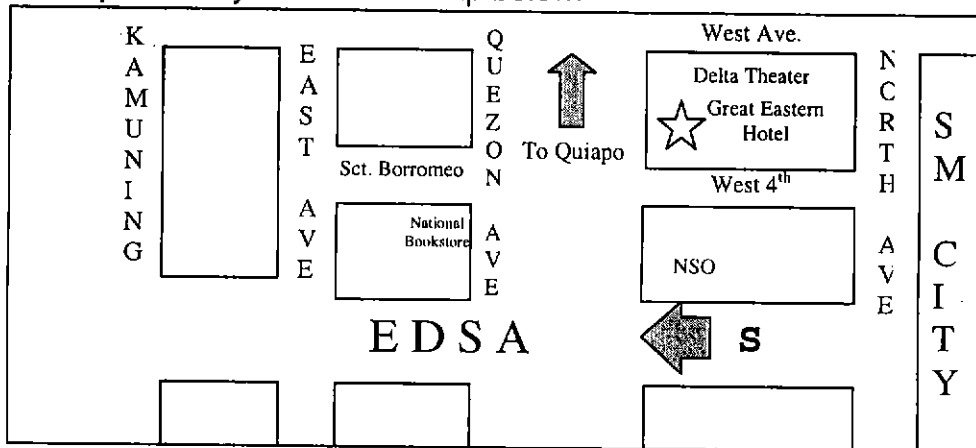

Guidelines for the CCFPI-SAS Reading Program Summer Workshop

1. A maximum of (2) participants per school may attend the summer workshop to include either the grade 3-4 teacher (for combination class) or grade 4 teacher (for monograde class) and the teacher-in-charge of the school/school head/principal.
2. No substitutes from the names submitted to the CCFPI head office will be allowed to attend the workshop.
3. The acceptable means of transportation for all participants shall be limited to the following:
 - Luzon participants
 - a. residence to bus terminal - by PUV
 - b. terminal (point of origin) to venue - by bus
 - Visayas/ Mindanao participants
 - a. residence to airport - by taxi
 - b. airport to Manila - by plane
 - c. NAIA to venue - by taxi

Porterage fees as well as fuel and oil cost for private vehicles are disallowed.

4. Participants may check-in at the hotel from 12:00 NN on Friday, May 23, 2003 and are expected to attend the orientation dinner at 6:00 pm at the assigned function room for the workshop. Participants may, likewise, check out after breakfast on Monday, May 26, 2003.

6. Participants are requested to wear appropriate clothing and bring sweaters or jackets. No slippers and/or shorts are allowed during the 2-day workshop.
