CORRIGENDUM TO DEPED MEMORANDUM NO. 60, S. 2003
(Training of Teacher-Trainers in English, Science,
Mathematics, and MAKABAYAN)

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Heads, Public Secondary Schools

1. Relative to the training of teacher-trainers in English, Science, Mathematics, and MAKABAYAN, the following changes are being made in Paragraph 1 of DepEd Memorandum No. 60, s. 2003:

- a. Due to the unavailability of the training venue, the opening program of the training of teacher trainers from the Luzon cluster of regions shall be on **March 30, 2003** at 3:00 p.m., instead of **March 29, 2003** and end on **April 4, 2003** at 3:00 p.m. instead of **April 3**;
- b. The venue for Cluster 2 (Visayas and Mindanao Regions) is the Sarabia Manor Convention Center, Iloilo City instead of Zamboanga City; and
- b. The training in Mathematics shall be extended from five (5) to six (6) days, i.e. *March 30-April 4, 2003* (instead of March 30-April 3) for Cluster 1 and *April 21-26* (instead of April 21-25, 2003) for Cluster 2.

2. Paragraph 5 is also corrected to read as follows:

- a. The board and lodging, supplies and materials for English and Science participants, transportation and honoraria of resource persons and the transportation expenses of BSE staff shall be charged against CONSTEL funds;
- b. The board and lodging of participants, resource persons and training staff, supplies and materials and honoraria of resource persons for Mathematics training program shall be charged against OSEC funds;
- c. The expenses for Makabayan training program which include board and lodging of participants and resource persons, supplies and materials and honoraria of resource persons shall be borne by the Bureau of Secondary Education (BSE); *Q*

- d. The transportation and other incidental expenses to be incurred by the regional participants shall be charged against local funds;
 - e. The board and lodging, supplies and materials, transportation of participants from the SEDIP Batch 1 provinces shall be funded by the Project; and
 - f. All expenses shall be subject to the usual accounting and auditing rules and regulations.
3. Immediate dissemination of this Memorandum is desired.
