- 2. The contestant should express his/her ideas and feelings on the theme "Pangalagaan Ang Bayan At Kinabukasan: Kabalikat Ka Ng Bayaning Beteranong Pilipino".
- 3. The Division Special Events Coordinator should coordinate with the Regional Special Events Coordinator for the Regional Contest. Likewise, the Regional Special Events Coordinator through the Regional Director should coordinate with the DepEd Special Events Unit. Entries should be sent/addressed to:

Theme - 40% Style and Language - 40% Organization - 20%

- 6. All entries must be accompanied by the following documents:
 - a. Bio-data/ current photo.
 - b. Aunthentication by the contestant that his/her entry has not been awarded in the other previous contest.
 - c. Endorsement of the contestant by the Head of the School, Regional/Division, Special Events Coordinator and the Regional Director.
 - d. All entries must be original and have never been published.
 - e. All entries must be witten in Filipino.
- 7. Prizes are to be awarded by the National Inter-Agency Task Force (NIATF) during the Tribute to the Filipino Heroes of Corregidor on April 7, 2003.

CREATIVE PAINTING COMPETITION

- 1. The Creative Painting Competition shall be open to high school students in the National Capital Region (NCR) only. There will be one (1) finalist in every division.
- 2. The theme of the competition/contest is "Pangalagaan Ang Bayan at Kinabukasan: Kabalikat Ka Ng Bayaning Beteranong Pilipino".
- 3. The painting should be in a poster type; have a poetic caption in two, three or four lines, free verse or with rhyme and meter, typewritten at the back of the painting (Filipino); done on a 18" X 24" illustration board; and the contestant can use any medium or coloring materials.
- 4. The criteria for judging include:

Originality - 40 %
Visual Impact - 30 %
Message - 30 %

- 5. The competition aims to memorialize the heroic deeds of the Filipino heroes depicting their victories during the World War II.
- 6. The regional contest shall be managed by the Regional Office to be headed by the DepEd Regional Director with members from DILG, VFP Sons and Daughters Associations, Inc., and or Defenders of Bataan and Corregidor (DBC).
- 7. Each division is entitled to one (1) entry. The judging will be on April 1, 2003 at the DepEd Ultra Pasig City.
- 8. There will be three (3) winners in this contest to be awarded by the NIATF on April 7, 2003 during the Corregidor Ceremonies.

1st Prize - PhP10,000.00 + trophy 2nd Prize - PhP 7,000.00 + trophy 3rd Prize - PhP 5,000.00 + trophy

VII. MGA ALINTUNTUNIN:

- 1. Ang desisyon ng mga nakararaming hurado ay ang siyang masusunod. Ang desisyon ay pangwakas at hindi maihahabol pa.
- 2. Ang mga kalahok at akda ng talumpati ay pipiliin ayon sa batayan at bilang. Walang pangalan ng kalahok, paaralan, probinsya, rehiyon, lungsod, kasarian at antas sa buhay.
- 3. Ang patimpalak ay bukas sa kahit na sinong mag-aaral na nasa mataas na paaralan o sa kolehiyo. Ang mga kaanak ng beterano ay hinihikayat na sumali.
- 4. Ang talumpating bibigkasin ay kailangang sariling katha na ginawa ng mananalumpati, di pa nalalathala at kailangang tumagal ng walong (8) minuto at hindi lalampas sa sampung (10) minutong pagsasalaysay. Sa bawat tatlumpung (30) segundong labis ay babawasan ng puntos.
- 5. Apat na malinaw na kopya ng talumpati na nakasulat sa mahabang sukat ng papel, na may numero lamang, walang sulat ng pangalan ng may-akda, kalahok, paaralan, probinsya o lungsod at rehiyon ang isusumite sa tagapangasiwa ng paligsahan.
- 6. Ang nilalaman ng talumpati ay hindi nararapat tumatalakay sa taliwas na prinsipyo ng demokrasya, makasakit ng paniniwala ng bawat relihiyon at higit sa lahat ay hindi lumalabag sa batas kalikasan, kapurihan, karangalan, at tamang kaugalian ng mamamayang Pilipino.
- 7. Ang taga-pangasiwa ng paligsahan ay may angking karapatan na ilathala ang mga napiling talumpati. Sila rin ay may kapangyarihang magpasya sa mga hindi sakop ng mga alituntuning ito.
- 8. Ang timpalak na ito ay lalahukan ng mga kinatawan mula sa bawat rehiyon upang piliin ang Pambansang Kampeon.
- 9. Ang mga nagwagi (pang-una at pangalawa) sa mga nagdaang paligsahan ay hindi na maaaring lumahok pa. Ang mga gantimpala ay ibibigay sa Abril 7, 2003 sa palatuntunan sa Corregidor.
