**TRAINING-WORKSHOP FOR PROGRAM IMPLEMENTERS OF THE CITIZENSHIP ADVANCEMENT
TRAINING (CAT)**

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Secondary Schools

1. The Bureau of Secondary Education (BSE) of the Department of Education (DepEd), shall conduct a Training-Workshop for Program Implementers of the Citizenship Advancement training (CAT) on May 13-16, 2003 at the Regional Educational Learning Center, Cepeda St, Concepcion, Marikina City.
2. The training-workshop aims to update the implementation on Citizenship Advancement Training (CAT), a restructuring of the Citizens Army training. The participants will also: (a) review the materials to be used in the implementation of the program; (b) plan community and public safety activities in accordance with the thrusts of the new program; and (c) develop Regional and Division training design.
3. Each region is requested to send six (6) participants, namely: (a) 1 MAPEH Regional Supervisor; (b) 1 MAPEH Division Supervisor; (c) 1 Secondary School Principal; (d) 1 4th year MAPEH teacher; (e) 1 Secondary School CAT Commandant and (f) 1 Barangay Chairman (where the school is located).
4. The names of the participants shall be forwarded to Ms. Bella O. Marinas, Officer-In-charge, Staff Development Division, Bureau of Secondary Education, 3rd Floor, Bonifacio bldg, DepEd Complex, Meralco Avenue, Pasig City, Attention: Mr. Edward Garcia, on or before April 28, 2003, by mail or telefax: 632-75-86.
5. Transportation expenses, per diem of the field participants and BSE staff shall be charged against local funds whereas board and lodging of all the participants and BSE staff shall be covered by BSE funds, subject to the usual accounting and auditing rules and regulations.
6. Immediate dissemination of this Memorandum to all concerned is desired.
