- 1. The Administrative Officers Association of the Department of Education (AOADE), Inc. in collaboration with the Administrative Service, Department of Education, will hold its First National Convention on May 27-29, 2003 at Teachers Camp, Baguio City with the theme "AOADE: The Catalyst of Change Towards Excellence in Basic Education".
- 2. The objective of the convention is for the DepEd Administrative Officers (AOs) to have comprehensive knowledge and effective administration of the Implementing Rules and Regulations (IRR) of Republic Act No. 9155 otherwise known as the "Governance of Basic Education Act of 2001". It further aims to provide the participants with opportunity to gain full understanding and confidence in implementing the Twelve (12) Point Program for Education.
- 3. The DepEd Administrative Officers (across levels) and Principals/Teachers acting as Administrative Officers in their respective schools are allowed to attend on official business.
- 4. A registration fee of Three Thousand Three Hundred Pesos (PhP3,300.00) will be charged each participant to cover the expenses on board and lodging, handouts materials, kits, other convention supplies and materials. All expenses incident to their participation shall be charged to local funds subject to the usual accounting and auditing rules and regulations.
- 5. The participants are advised to report to the convention venue a day before the scheduled start of the convention and should check out one day after the end of the convention.
