**ENRICHMENT WORKSHOP FOR THE GENDER AND DEVELOPMENT (GAD)
AND PEACE EDUCATION TEACHING EXEMPLARS**

To: Regional Directors
Schools Division/City Superintendents

1. The Department of Education (DepEd) through the Staff Development Division-Human Resource Development Service (SDD-HRDS) and in cooperation with the Office of the Presidential Adviser on the Peace Process (OPAPP) will conduct an Enrichment Workshop for the Gender and Development (GAD) and Peace Education Teaching Exemplars on May 26-30, 2003 at the Bayview Hotel, Roxas Boulevard, Manila.
2. This activity is in line with the implementation of Republic Act No. 7192, "Women's in Development and Nation Building Act" and Executive Order No. 6, s. 1993, "Creating and Nurturing a Climate Conducive to Peace". The objectives of the workshop are the following:
 - a. To enrich the integrative strategies/approaches adopted in the teaching exemplars;
 - b. To develop enrichment activities for higher level thinking skills development;
 - c. To come-up with finalized compilation of the GAD and Peace Teaching Exemplars including supplementary readings/instructional materials; and
 - d. To prepare guidelines/mechanics for the launching and orientation on the use of the teaching exemplars among classroom teachers.
3. The list of writers and project staff for the workshop is enclosed. All writers and staff are expected to be at the venue on the first day for preliminary activities and orientation.
4. Board and lodging expenses, transportation and per diem of writers and project staff, supplies, contingency, honoraria of writers and staff and overtime pay of HRDS/NEAP writers and staff are chargeable against HRDS Special Program Funds subject to the usual accounting and auditing rules and regulations.
5. Immediate dissemination of this Memorandum is desired.
