1. The Philippine Public Schools District Supervisors Association will hold its 3<sup>rd</sup> Annual Convention on June 27-28, 2003 at the Mimosa Golf and Country Club, Mimosa Leisure Estate, Clark Field, Pampanga.

2. The convention aims to:
