## PHILIPPINE HOME ECONOMICS ASSOCIATION (PHEA) ANNUAL CONVENTION

- 1. The Philippine Home Economics Association (PHEA), in coordination with the Department of Education, will hold a three-day Annual Seminar-Convention in Home Economics Education on October 16-18, 2003 at Teachers Camp, Baguio City.
- 2. The theme of the convention is "Healthy Family Lifestyle in the 21<sup>st</sup> Century: Present Situation, Cooperation and Future Action."
- 3. The objectives of the convention are to:
  - a. have a clearer perspective of the emerging modern family as a vital force of society;
  - b. analyze the role and challenges of Home Economics Education towards the improvement of quality family life;
  - c. identify innovative options and strategies to strengthen family solidarity and healthy family lifestyle; and
  - d. plan alternative approaches to respond to the wholesome social, economic, moral and spiritual development of the family.
- 4. A registration fee of Three Thousand Three Hundred Pesos (PhP 3,300.00) will be charged each participant to defray expenses for lodging and accommodation including meals and snacks and for supplies, reading materials and books. Participants representing public schools are allowed to attend **on official time only.** Private school participants can make financial arrangements with their respective institutions.
- 5. Participants to the convention include regional and division supervisors, school heads/principals, department heads of the Technology and Livelihood Education (TLE) formerly THE, and EPP, chairmen and coordinators, TLE and EPP teachers, Agriculture teachers, TLE-DepEd scholars representing their respective regions.
