**NEW REGISTRATION SCHEDULE FOR THE 2003 NATIONAL REGULAR PHILIPPINE  
EDUCATIONAL PLACEMENT TEST (PEPT)**

To: Bureau Directors  
Regional Directors  
Schools Division/City Superintendents  
Heads, Public and Private Elementary and Secondary Schools  
Vocational High School Principals


1. Registration for the National Regular Examination in the Philippine Educational Placement Test (PEPT) which has been set from August 1 to September 30 every year, as stipulated in DepEd Order No. 32, s. 2002, is hereby repealed. Starting this school year, registration shall be from July 1 to September 30 to provide ample time for out-of-school youth to register.

2. Submission of the report on the total number of registrants grouped by age and grade/year level, which has been set on October 3, shall remain as is. Non-compliance on this provision will affect the financial and test material allocations of this Office.

3. Relative to the registration for the 2003 Regular PEPT, registrants in the following 22 schools divisions shall be the respondents in a research project of the National Education Testing and Research Center (NETRC):

Region I	La Union and Pangasinan II
Region II	Isabela and Cagayan
Region III	Tarlac, Bataan, and Bulacan
Region IV	Batangas Province, Cavite Province, Rizal, Quezon, Laguna, and San Pablo City
Region V	Sorsogon, Albay and Camarines Sur
CAR	Baguio City and Ifugao
NCR	Manila, Quezon City, Calocan City and Valenzuela City

4. Registrants who have work experience and are from the schools divisions mentioned above shall be required to submit the following documents, in addition to the usual registration requirements:

- a. Certificate of Employment or photocopy of a Business License, if self-employed;
- b. Service Record; and
- c. Outstanding Award or Citation received (if any). 

5. The list of registrants stated in Paragraph 4, together with the documents required, shall be submitted to the NETRC for further evaluation and assessment during the National Orientation Conference in the venues and on the dates to be announced later.
6. Registration forms (PEPT Form 1) which are not used shall be returned to NETRC thru its authorized representative during the retrieval of test materials. Since registration forms are accountable forms, the corresponding amount for unreturned registration forms shall be credited to the registering officer.
