REGIONAL TRAINING PROGRAM FOR SCHOOL PAPER ADVISERS

To: Bureau Directors
Regional Directors

Schools Division/City Superintendents

- 1. Pursuant to the provisions of RA 7079, otherwise known as the Campus Journalism Act of 1991, mandating the Department of Education to provide training programs/seminars for teacher-advisers, the Regional Training Program for School Paper Advisers, which is a follow through of the National Training Program for School Paper Advisers held at Teachers Camp, Baguio City on May 10-12, 2003, shall be conducted between August 1 and September 5, 2003.
- 2. The theme of this year's training program is "Expanding the Reach of Campus Journalism Through Information and Communication Technology". The training aims to:
 - a. equip school paper advisers with the necessary skills in radio scriptwriting and broadcasting;
 - b. enable the school paper advisers to prepare a script for a five-minute news segment; and
 - c. prepare the participants for the presentation of a simulated news segment.
- 3. Participants to this training program are school paper advisers from the secondary and elementary schools. Attendance to the seminar shall be determined by the division supervisors in coordination with the local division school paper advisers associations at the elementary and secondary levels. Traveling expenses of the participants, members of the working committees and facilitators shall be charged against local school funds subject to usual accounting and auditing rules and regulations.
- 4. A subsidy of Ten Thousand Pesos (PhP10,000.00) per division shall be released to the Director of the DepEd Regional Office upon submission of the training design to BSE not later than July 30, 2003. Enclosed is the list of monitors and their respective assignments.
