# MORATORIUM ON THE ISSUANCE OF CODES TO PRIVATE LENDING INSTITUTIONS

To: Regional Directors

Schools Division/City Superintendents

District Supervisors

Heads, Public Elementary and Secondary Schools

- 1. As moved by the Management Committee (MANCOM) at its June 2003 meeting, this Department announces a moratorium in the grant of lending codes to private lending institutions looking to avail of the Department's Automatic Payroll Deduction System (APDS).
- 2. The moratorium will commence on August 16, 2003 and will be in force until this Office issues a Memorandum to the contrary. No applications for lending codes will be accepted after the close of business hours (5:00 p.m.) on August 15, 2003 (Friday).
- 3. The moratorium is limited to lending codes only. Insurance and Mutual Assistance System (MAS) codes will be the subject of a separate review to commence on August 18, 2003 under the Office of the Undersecretary for Finance and Administration.
- 4. It is strongly advised that any teacher wishing to avail of lending through the APDS borrow only from accredited private lending institutions whose effective interest rates are 18% or below per annum, with service fees not to exceed 6% of the principal borrowed.
- Immediate dissemination of this Memorandum is desired.
