THE 2003 MTAP-DEPED SATURDAY MATHEMATICS PROGRAM

To:

Regional Directors

Schools Division/City Superintendents

Heads, Private and Public Elementary and Secondary Schools

- 1. The Mathematics Teachers Association of the Philippines (MTAP) in collaboration with the Department of Education (DepEd) will conduct the 2003 MTAP-DepEd Saturday Mathematics Program for private and public elementary and secondary schools.
- 2. The Program aims (a) to provide students the opportunity to explore Mathematics without the threat of tests; (b) review the materials used in previous year to enable students to do well in Math this school year; (c) prepare the Grade VI and fourth year students for the entrance examination for first year high school and college levels respectively and (d) prepare talented students for the Metrobank-MTAP-DepEd Math Challenge Competition.
- 3. The Saturday Mathematics Program for Regular Students will be conducted on six (6) Saturdays from September 6 to October 11, 2003. The sessions will be for the 25th to the 85th percentile of the students at each grade/year level from Grade I to Fourth Year.
- 4. The Program for Talented Students will be held for seven (7) Saturdays except November 1, from October 18 to December 6, 2003. The sessions will be designed for the top 15% Grade I to Fourth Year high school students in a school.
- 5. In addition to the permit of the parent/guardian, the school principal shall indorse students who wish to participate in this Program.
- 6. There will be a nominal fee of Two Hundred Pesos (PhP200.00) for the six (6) sessions and Two Hundred Fifty Pesos (PhP250.00) for the seven (7) sessions, which must be paid at the Center, on or before September 6, 2003. Strict adherence to the deadline is necessary to prevent any disorder in organizing classes on September 6, 2003.
- 7. Parents of students who will participate in the program will be required to sign the Parent Permission Form. Please see Enclosure No. 1.

- 8. The Guidelines for Trainers and Center Coordinators are contained in Enclosures Nos. 2 and 3 respectively.
