4th ANNUAL CONVENTION OF THE PHILIPPINE ASSOCIATION OF EDUCATION SUPERVISORS (PAES)

To: Regional Directors

Schools Division/City Superintendents

- 1. The Philippine Association of Education Supervisors (PAES) will hold its 4th Annual National Convention with the theme "PAES: A Vital Force to Instruction Reform". This shall be held on September 23-26, 2003 at the Barcelo Asturias Hotel, Puerto Princesa City, Palawan.
- 2. The Convention aims to:
 - a. strengthen supervisory and instructional competencies of education supervisors;
 - b. acquire relevant and updated knowledge on the state of BEC implementation; and
 - c. concretize the roles and functions of education supervisors in the light of IRR of RA 9155.
- 3. Participants to this Convention are all regional and division education supervisors or subject area coordinators.
- 4. A registration fee of Three Thousand Eight Hundred Pesos (PhP3,800.00) shall be charged each participant to defray expenses for hotel accommodation, meals, honoraria of resource speakers, convention kit and other operational expenses. This shall be charged against local school board funds or other sources. Only cash payments will be accepted. Participants are expected to register in the afternoon of Tuesday, September 23, 2003. First meal shall be the dinner on said date while last meal (lunch) shall be served on September 26, 2003.
- 5. All PAES Officers and Board of Directors are expected to arrive at the venue on Sunday, September 21, 2003 for convention preliminaries.
