2003 NATIONAL CHILDREN'S SCIENCE INTERACTIVE WORKSHOP

To: Regional Directors Schools Division/City Superintendents Heads, Public and Private Elementary Schools

- The Philippine Society of Youth Science Clubs, Inc. (PSYSC) announces its annual activity, the 2003 National Children's Science Interactive Workshop (CSIW 2003) to be held on October 20-24, 2003 at Dumaluan Beach Resort, Panglao, Bohol for PSYSC-affiliated elementary students nationwide.
- The activity's theme shall be "Bio Adventure: Exploring the Map of Life". The CSIW aims to: provide learning experiences to participants and enable them to enrich their knowledge about Anatomy, Botany, Zoology and Ecology; and to promote environmental advocacy and awareness. It will be composed of a series of lectures, workshops, situationers, syntheses, group dynamics, and field trips.
- Each science club can send a maximum of five (5) Grade IV to VI pupils only and one (1) teacher-adviser. Attendance of public school participants is on official time only.
- Travel expenses, registration fee of Three Thousand Three Hundred Pesos (PhP3,300.00) and other incidental expenses to this activity maybe charged against local school board funds, subject to its availability and the usual accounting and auditing rules and regulations. The registration fee will cover lodging and meals (from dinner of October 20 to lunch of October 24), handouts, field trips, and other miscellaneous expenses.
- Interested participants must submit the following: (a) duly accomplished application 5. forms; (b) the principal's endorsement letter for the whole delegation; (c) parental consent; (d) medical certificate (including adviser); and (e) a non-refundable reservation deposit of Seven Hundred Pesos (PhP700.00) per participant (deductible from the registration fee). This reservation fee shall be payable only to Philippine Society of Youth Science Club, Inc., (PSYSC, Inc.) Landbank of the Philippines Account No. 0702-1020-65 or Postal Money Order at Philippine Society of Youth, Science Clubs, Inc. (PSYSC, Inc.), Apartment B, #7 Esteban Abada St., Katipunan Ave., Loyola Heights, Quezon City 1108
- Application Forms shall be sent directly to PSYSC affiliated schools.
