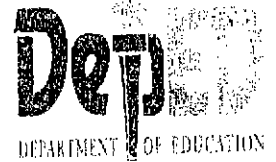

ADDENDUM AND CORRIGENDUM TO DEPED MEMORANDUM NO. 284, S. 2003  
(Paligsahan sa Kasaysayan at Kultura ng Pilipinas)

To: Regional Directors  
Schools Division/City Superintendents  
Heads, Public and Private Secondary Schools

1. In connection with the "Paligsahan sa Kasaysayan at Kultura ng Pilipinas" (PSKPP 2003-2004) per DepED Memorandum No. 284, s. 2003, the following are the revised and amended rules and mechanics:

- 1.1. The PSKPP 2003-2004 Regional Elimination Rounds shall be implemented and conducted by the National Historical Institute (NHI) in sixteen (16) regions of the Department of Education (DepED) nationwide; and
- 1.2. For the newly subdivided regions, namely Region IV-Calabarzon and IV-Mimaropa, the following guidelines shall be adopted: a) each Regional Office shall supervise the division elimination rounds in their region; b) each region will get the top fifteen (15) contestants who may qualify at the regional elimination rounds to be supervised by the NHI later; c) in order to utilize the available facility for the implementation of the PSKPP 2003-2004, the venue of the regional elimination rounds for the newly subdivided region shall be the existing DepED RELC or any available venue to be determined by the NHI and concerned DepED Regional Directors; and d) the first prize winner from the aforementioned PSKPP regional elimination rounds shall officially represent both the newly subdivided DepED regions to the PSKPP 2003-2004 Grand National Finals in Manila on March 5, 2004.
