TRAININGS OF TRAINORS AND TEACHERS ON HUMAN RIGHTS EDUCATION (HRE)

To:

Bureau Directors

Regional Directors

Schools Division/City Superintendents

Heads, Public Elementary and Secondary Schools

- 1. Following the launching of the Human Rights Education Teaching Exemplars, the Department of Education (DepED), through the Staff Development Division-Human Resource Development Service (SDD-HRDS) and the Commission on Human Rights (CHR) will conduct the Training of Trainors (TOT) and Teachers on Human Rights Education (HRE).
- 2. The in-service training for teacher-participants is generally aimed at transforming them to become effective human rights teacher equipped with relevant content, skills and attitude to effectively integrate human rights values in their respective learning areas.
- 3. The schedule of activities and participants under this trainings are as follows:

Activities	Date	Participants
Training of HRE Trainors (TOT)	February-July 2004 (see enclosure for specific schedules)	5 participants from each regions composed of: 1 regional supervisor (ES II)* 1 division supervisor (ES I)* 2 master teachers (MTs)* 1 principal* * preferably in charge of MAKABAYAN or Values Education
In-Service Training of Teachers	to be determined during the (TOT)	classroom teachers regardless of learning area, to be identified by the regional and division offices
Monitoring of the In-Service Training (INSET)	according to regional/ division schedules	SDD-HRDS trainors, invited field resource persons and CHR monitors/trainors

- 4. Travel expenses and per diem of participants are chargeable against local funds while board and lodging of participants and staff are to be shouldered by the DepED and CHR on 50%-50% cost sharing. Other expenses including honoraria of external resource persons, supplies, travel expenses and per diem of SDD-HRDS personnel and invited field resource persons and contingency funds are chargeable against HRDS Special Programs subject to the usual accounting and auditing rules and regulations.
- 5. Immediate dissemination of this Memorandum is desired.
