#### DEPED INTEGRATED SHORT-TERM SCHOLARSHIP PROGRAM FOR SUMMER 2004

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Heads, Public Elementary and Secondary Schools

- 1. The Department of Education (DepED) through the Staff Development Division, Human Resource Development Service (SDD-HRDS) announces the DepED Integrated Scholarship Program for Summer 2004 to be conducted by the University of the Philippines College of Education (UPCE), Diliman, Quezon City from April 12 to May 8, 2004 (22 contact days). The short-term courses are offered to both elementary and secondary school teachers.
- 2. The courses aim to upgrade the teaching competencies of teachers in the learning areas where priority training needs have been identified and to facilitate better understanding of the content and integrative processes currently adopted in the restructured Basic Education Curriculum (BEC).
- 3. Each region is allocated three (3) slots each for each course. In the distribution of slots, it is advised that Depressed, Disadvantaged and Underserved (DDU) schools, districts and divisions be given priority.
- 4. The screening of nominees shall be done by the Regional Integrated Scholarship Committee (RISC). A copy of the evaluation sheet and the ranking list of nominees shall be forwarded to the SDD-HRDS, Department of Education, Meralco Avenue, Pasig City. The deadline for the submission of nominees is on **March 28, 2004**. Selected nominees shall submit to the SDD-HRDS duly accomplished CS Form 212 with a 2"x2" recent photo and signed scholarship contract upon their arrival in Manila. Participants are strictly advised to attend the first day of classes. Enclosed are the list of courses offered, criteria for Selection of Nominees for the Short-Term Courses and pertinent papers for submission to RISC.
- 4. Grantees of the program are entitled to their salaries, free tuition fee, stipend of Five Thousand Pesos (PhP5,000.00) and reimbursement of travelling expenses to and from Manila. Complete travel support documents should be submitted to the DISP Coordinator during the orientation on the first day of classes. Travelling expenses and stipend of grantees will be paid at the Central Office after the submission of the official enrolment list by the UP College of Education.
- 5. Expenses for this program are chargeable against the Teachers Scholarship and Fellowship Grants Funds (A.1.a.1.d.4).

- 1. A bachelor's degree holder related to the area of scholarship nominated to with a grade point average of not lower than 2, B or 85.
- 2. Has been a permanent teacher for at least three (3) years with a performance rating of very satisfactory (VS) or better. For secondary teachers, knowledge and skills in developing learning/teaching modules is preferred.
- Is actually teaching the subject nominated to.
- Not more than 50 years of age.
- Has no pending administrative case and/or criminal record.
- 6. Has been certified by a government physician to be physically and mentally fit.
- 7. Has not availed of any scholarship/training program for the last two (2) years.
- Possesses leadership potential, positive attitude and commitment.
- 9. Can communicate adequately in both English and Filipino.
