> WORKSHOP ON RECONCILING THE 2ND EDITION OF THE GRAFT AND CORRUPTION PREVENTION TEACHING EXEMPLARS WITH THE BASIC EDUCATION CURRICULUM

To: Regional Directors **Bureau Directors** Schools Division/City Superintendents

- The Staff Development Division, Human Resource and Development Service (SDD-HRDS) and the Office of the Ombudsman will jointly conduct a Workshop on Reconciling the 2nd Edition of the Human Rights Education (HRE) Teaching Exemplars with the Basic Education Curriculum (BEC) on April 19-23, 2004 at Tagaytay Haven, Tagaytay City and Critiquing and Final Revision of the Graft and Corruption Prevention Education (GCPE) Teaching Exemplars on May 31-June 4, 2004 at La Bea Resort, Calamba, Laguna.
- The objectives of the workshop are to: a) identify entry points for the integration of graft and corruption concepts in the basic education curriculum; b) revise and critique the latest edition of the exemplars; and c) formulate succeeding steps relevant to the launching of the 2nd edition of the Graft and Corruption Teaching Exemplars.
- Participants to the workshops are selected field writers, representatives of the Office of the Ombudsman, SDD-HRDS/NEAP technical staff and curriculum writers of the Bureaus of Elementary and Secondary Education.
- 4. Travel expenses of participants are chargeable against local funds while board and lodging expenses, honorarium of external resource persons, travel expenses of SDD participants and staff, supplies, extra duty allowance of project staff and other incidental expenses are chargeable against HRDS Special Programs, subject to the usual accounting and auditing rules and regulations.
- 5. Immediate dissemination of this Memorandum is desired.
