THE 62nd COMMEMORATION OF THE ARAW NG KAGITINGAN AND PHILIPPINE VETERANS WEEK

- 1. The Memorandum Order No. 131 dated January 20, 2004 issued by President Gloria Macapagal-Arroyd directs the Department of National Defense to spearhead the 62nd Commemoration of the *Araw ng Kagitingan and Philippine Veterans Week* on April 5-11, 2004 with the theme "Beterano: Kalayaan at Ginhawa Natin Ngayon, Bunga ng Katapatan at Kagitingan Mo Noon". This will be in coordination with all the government agencies and non-government organizations and associations for the duration of the celebration.
- 2. The objective of the celebration is to memorialize the heroic deeds of the Filipino Veterans and to uphold the democratic principles and nationalistic ideals of the Filipino people especially the youth.
- 3. As a member of the National Inter-Agency Task Force (NIATF), the Secretary encourages all DepED regional, division and school officials to hold meaningful and fitting activities with the participation of students in both public and private schools. Teachers in MAKABAYAN are also encouraged to conduct a lesson-centered activity on: *The Filipino-American War: Heroism of Filipinos*.
- 4. There will be a National Oratorical Contest on the theme "Katarungan para sa Beterano, Kailan Pa?" sponsored by the VFP-SDAI. The division/regional contest shall be managed by the division/regional offices headed by the Schools Superintendent/Regional Director with their Special Events Coordinators in cooperation with the VFP-SDAI Regional Vice-President and or the Post and District Presidents. Expenses incurred during the conduct of the contest (Division/Regional levels) shall be charged to local school board funds subject to the usual accounting and auditing rules and regulations.
- 5. All pupils and students are encouraged to watch a program showing footages/historical facts and events on World War II every Saturday, 9:00 am to 10:00 am from February 7 to April 24, 2004.

Oct. 6, 1945	Recruitment of Special Philippine Scout called "New Scouts" under the U.S. Armed Forces Voluntary Recruitment Act of 1945 or United States Public Law 79-190	To perform occupational duty in the Pacific entitling them to same veterans benefits granted to members of the Commonwealth Army of the Philippines but it never equalled the pay scale of the U.S. Army soldiers.
Feb. 18, 1946	79th U.S. Congress passed the First Supplemental Surplus Appropriation Rescission Act, United States P.L. 79-301. embodying a "legislative rider" that provides: "that service in the organized military forces of the Government of the Commonwealth of the Philippines, while such forces were in the service of the armed forces of the United States pursuant to the military order of the President of the United States dated July 26, 1941, shall not be deemed to be or to have been service in the military or naval forces of the United States or any component thereof for purposes of any law of the United States conferring rights, privileges and benefits upon any person by reason of the service of such person or the service of any other person in the military	The Rescission Act of 1946 declared the service performed by Filipino veterans as not "active service" for purposes of rights to priviledges and benefits. Exempted are those with service connected disability or those who died in action and whose survivors are granted benefits, but these are paid 50 cents to a dollar. The funds were part of the \$200 million that was allocated as econamic and political assistance to the Philippines. The appropriation was embodied in a "lelgislative rider" provision that was railroaded and did not pass through a committee hearing as required by parliamentary rules.
