- 1. The Bureau of Secondary Education (BSE) through the Staff Development Division (SDD) shall conduct a five-day training workshop on Assessment for Learning: Practices, Tools and Alternative Approaches with the aim of upgrading the capabilities of regional teacher trainers in the use of various tools and alternative approaches for assessing learning.
- The training workshop shall be conducted by cluster as follows:

- 3. The Regional Office (RO) shall submit the list of participants per subject area from public and private schools to the SDD, BSE (Attn.: Ms. Ma. Elsie C. Esmer) at fax nos. (02) 632-7586 and (02) 636-5172 and on or before **March 12, 2004** for cluster 1, **and April 5, 2004** for cluster II. The list of participants duly endorsed by the RO shall be deemed confirmed.
- 4. A registration fee of Five Thousand Pesos (PhP5,000.00) shall be charged each participant from the private schools. Transportation and travelling expenses of the participants from public schools shall be charged against local funds. All other training expenses (board and lodging, travelling expenses of the training staff, honoraria of resource speakers and other administrative costs) shall be charged against BSE funds, subject to the usual accounting and auditing rules and regulations.
