To optimize the use of the Department's limited resources, there shall be a synchronized planning of program/activities with budgets for all central and regional offices covering FY 2004-2005. In this regard, please be advised as follows:

Reconstitution of the Programs Committee (PROGCOM). This Committee is hereby reconstituted as follows:

Undersecretary for Programs and Projects

Co-Chair:

Undersecretary for Regional Operations

Vice-Chair:

Assistant Secretary for Programs and Projects Assistant Secretary for Planning and Development

Members:

Directors of BEE, BSE, BNFE, NETRC, NEAP, HNC,

IMCS, and TEC

Regional Directors of NCR and IV-B

PROGCOM as reconstituted, shall review all agency proposals for FYs 2004-2005 in terms of programs/projects to be pursued for the subject years. Secretariat services will be provided by the Office of Planning Service, particularly the Planning and Programming Division.

Plans must emphasize the program results chain (inputs-outputsoutcomes/impact) to facilitate measurement of progress achieved over time. The proposed programs should show quite clearly how they build on previous, related initiatives, or whether they are a continuation of the previous year's initiatives. There should be full disclosure about the future directions being pursued.

Creation of the Finance Committee (FINCOM). To support the PROGCOM in the determination of appropriate programs and activities for the Department that will require resources, there is hereby created a Finance Committee with the following composition:

FINCOM shall determine the appropriateness, completeness and reasonableness of the cost estimates reflected in the agency submissions duly endorsed by the PROGCOM. Also to be considered are the prior years spending levels of the office concerned to determine feasibility of targets being set. To assist FINCOM in the discharge of its functions, the FMS-Budget Division is hereby designated as its overall Secretariat.

- Both PROGCOM and FINCOM are hereby directed to prescribe specific guidelines, schedules and coordination arrangements to be employed for the ensuing review of agency submissions for the FY 2005 budget proposals Consultations with proponent agencies will be held along the way.
- 3. As a matter of policy, only the programs/activities with budgets, which both Committees will recommend favorably, will be formally approved by the DepED Executive Committee and will therefore, be allowed to commit specific resources of DepED. Attachment 1 shows the perceived flow of this new system to be employed.
- 4. Both Committees are also authorized to hold workshops/conferences and to tap resource persons, as deemed necessary, in the discharge of their respective functions.
- All DepED orders and other issuances inconsistent herewith are hereby revoked or modified.
- 6. Immediate dissemination of this Memorandum is desired, and heads of offices are encouraged to discuss this with their respective officers/staff to ensure that everyone is fully informed.
