## BASIC MANAGEMENT COURSE FOR HEALTH AND NUTRITION PROGRAM MANAGERS

To: Bureau Directors
Regional Directors
Directors of Services, Centers and Heads of Units
Schools Division/City Superintendents

- 1. In line with the Department of Education's (DepED) efforts to enhance capabilities of school administrators and program managers, the National Educators Academy of the Philippines (NEAP) and the Staff Development Division, Human Resource Development Service (SDD-HRDS), in coordination with the Health and Nutrition Center (HNC), announce the conduct of the Basic Management Course for the 1<sup>st</sup> batch of Health and Nutrition Program Managers at the regional and division levels on June 3-9, 2004 at NEAP, Teachers Camp, Baguio City.
- 2. The course aims to:
  - enhance participants' knowledge on the nature and functions of management;
  - increase understanding on the organizational structure and directions of the Department of Education as well as the relevant provisions of R.A. 9155 and the Basic Education Curriculum;
  - provide the participants opportunities to re-examine their personal and professional readiness vis-à-vis the demands of their jobs and the over all direction of the Integrated School Health and Nutrition Program; and
  - equip the participants with basic managerial competencies and leadership skills.
- 3. Participants are the medical officers and dentists at the regional and division levels who are tasked to manage the Integrated School Health and Nutrition Program. The enclosed list contains the names of those who are already endorsed by HNC to NEAP and SDD-HRDS.
- 4. The <u>Health and Nutrition Center</u> shall take charge of the travel expenses of participants and the registration fee of Seven Thousand Five Hundred Pesos (P7,500.00) per participant to defray expenses for <u>board</u>, <u>handouts and reference materials</u>, <u>professional fee of resource persons</u>, <u>honorarium of facilitators and staff</u>, <u>rental of function room</u>, <u>supplies and materials including course kits</u>, <u>and other related training expenses</u>. Expenses for travel, board and lodging of HNC officials who will be monitoring the activity and selected staff from the Accounting and Cash Divisions shall, likewise, be shouldered by HNC.

Members of HNC Technical Staff who will be participants in the training shall pay the registration fee. Expenses for lodging of participants, facilitators, staff and resource persons as well as the board, transportation and per diems of resource persons, facilitators and staff, shall be drawn from SDD-HRDS Training and Development Funds.

- 5. All participants are advised to report to the training venue in the afternoon of June 2, 2004 for registration, orientation and initial assessment. Participants who report in the afternoon of Day 1 **shall not be allowed** to proceed with the course.
