Public and private school teachers and other members of the Board Election Inspectors who are registered in the cities or municipalities where they are stationed may vote for candidates in the local and national levels.

On the other hand, public and private school teachers and other members of the BEI who are registered in cities or munic palities other than their places of assignment may vote for candilates for national positions only. In this case, they shall be considered as local absentee voters like members of the police and the military.
