- 1. With reference to DepED Order No. 4 s. 2002 dated 13 February 2002 and DepED Memorandum No. 20 s. 2003 dated 22 January 2003, the following changes are hereby made:
 - 1.1 Undersecretary Fe A. Hidalgo and Manaros B. Boransing are hereby designated as chair and co-chair, respectively, of the Project Coordinating Committee. Assistant Regional Director Susana Teresa B. Estigoy shall continue to be the Philippine Project Manager. She will be responsible for the day-to-day operations of the project and shall report on a regular basis to the EDPITAF Director.

1.3 Directors Diamar Kadon (Region XI), Estrella A. Babano (Region XII) and Leovigilda P. Cinches (ARMM) are hereby designated as Regional Project Coordinators. They will be responsible for facilitating, assisting and supporting project implementation.

- 1.4 It is understood that they will continue to draw their salaries and other entitlements from their respective offices.
- 1.5 Being the executing agency, EDPITAF shall continue to be responsible for the overall project coordination through the Project Coordinating Unit (PCU). The EDPITAF Director who serves as the chief technical person overseeing project implementation will assist the Deputy Project Director/Chair.
- 2. All other provisions in previous issuances that are consistent with the above revisions shall remain to be in effect unless revoked earlier or until project completion.
- 3. All GOA and GOP officials and staff will endeavor to establish and maintain a harmonious and effective working relationship.
- 4. Immediate dissemination of this Memorandum is desired.
