INSURANCE COMPANIES AND MUTUAL AID SYSTEM (MAS) ORGANIZATIONS ACCREDITED TO THE AUTOMATIC PAYROLL DEDUCTION SYSTEM (APDS)

- 1. The DepED has almost completed the Phase II of the Program to Clean-up Automatic Payroll Deduction System (APDS) which is the accreditation/reaccreditation of Insurance Companies and Mutual Aid System (MAS) organizations. Enclosed is a partial list of insurance companies and MAS organizations already reaccredited/accredited to the Department's APDS, for your guidance and ready reference.
- 2. The program aims to help teachers with prompt payment of authorized obligations to insurance companies/MAS organizations and to ensure that the APDS is properly maintained and regulated, in order to protect and secure DepED teachers' and other personnel's welfare and well-being.
- 3. Similar to the accredited PLIs to APDS, insurance companies and MAS organizations are only authorized to operate in regions where they have offices or branches or agency to whom teachers can have access in case of a complaint or issue.
- 4. Accredited Insurance Companies and MAS organizations offering more than one (1) product to DepED teachers and employees are assigned sub-codes for easy identification of accounts. The assigned sub-codes to these organizations depend on how many types of products are offered to DepED teachers and employees. The said sub-codes, however, are not to be transferred, for sale or for further assignment to any other entity.
- 5. The rates of interest and other charges to be charged for policy or any other loans being offered by the said organizations shall be based on the rates indicated in the enclosed list. These organizations may also offer lower rates but not beyond what is specified in the said list and/or APDS-MOA. It is worthy to mention that the DepED in coordination with the Insurance Commission has determined allowable rates to be imposed on policy or any other loans of these organizations. \not

- 6. The Central/Regional Payroll Services Units shall deduct from the monthly remittances 3% for insurance companies regardless of product offered and 1% for MAS organizations (Teacher Associations/Cooperatives) as DepED Service Fee. These Units are prohibited to collect more than the specified service fee. Any report of overcharging will be dealt with by this Office for failure to follow the Department policy.
- 7. The said list of accredited insurance companies and MAS organizations will continue to be updated on a regular basis. A list should be provided for posting in all schools of each region highlighting the information provided.

8. Immediate dissemination of this Memorandum is desired.
