NATIONAL BI-ANNUAL CONSULTATIVE CONFERENCE OF SECONDARY EDUCATION DIVISION CHIEFS AND ASSISTANT CHIEFS

- 1. In collaboration with the Bureau of Secondary Education (BSE), this Department, the Philippine Association of Secondary Education Division Chiefs and Assistant Chiefs (PASECAC) shall conduct a four-day consultative conference on August 16-19, 2004 (inclusive of travel time) at Grand Regal Hotel, Davao City.
- 2. The conference aims to: a) thresh out issues and concerns on the implementation of various BSE-DepED programs and projects in the regions, particularly on the Bridge Program; b) update field implementers on current developments in secondary education; c) share best practices, experiences, and regional initiatives in secondary education; and d) address issues and concerns of the association.
- 3. A registration fee of Three Thousand Five Hundred Pesos (PhP3,500.00) shall be charged each participant to cover the cost of board and lodging, kit and materials. Travel and other incidental expenses relative to the participants' attendance in this conference shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
