FOURTH STAFF DEVELOPMENT SEMINAR OF THE DEPARTMENT OF EDUCATION MEDICAL OFFICERS ASSOCIATION (DEMOA) INC.

1. The Department of Education Medical Officers Association (DEMOA) Inc., in cooperation with the Health and Nutrition Center (HNC), this Department, will hold its 4th Staff Development Seminar on September 21-23, 2004 at the McArthur Inn, Palo, Leyte. The theme of this year's seminar is "The Medical Officer: Adapting to Changing Times and Needs".

2. The objectives of the seminar are to:

a. provide updates on the thrusts and challenges of the Integrated School Health and Nutrition Program (ISHNP);

b. present strategic options for the effective delivery of basic health and nutrition services;

 update the members on the current medical trends and practices in the pursuit of excellence in the delivery of health services; and

d. bring together the schools medical officers of the DepED so that they will work as one, moving and working for a common goal in the delivery of health services to the school population.

- 3. The participants to this seminar are the HNC Health Division staff and medical officers from the public and private schools.
- 4. In view of the scientific and technical benefits that may be derived from the convention and in compliance with the provision of Executive Order No. 266 re: Continuing Professional Education (CPE) Program, school medical officers are encouraged to attend **on official business**. Transportation and other expenses of the participants incident to their attendance to the seminar, including a registration fee of Two Thousand Seven Hundred Pesos (PhP2,700.00) for board and lodging, snacks, kits, certificates and other incidental expenses shall be charged from local funds subject to its availability and to the usual accounting and auditing rules and regulations. Participants from private schools shall make financial arrangements with their respective schools.
