CIRCULAR NO. 2004-01

On 19 December 2003, PCAB issued Resolution No. 949, s. 2003 and on 16 January 2004, Resolution No. 001, s. 2004. Succinctly, PCAB Resolution 949 adjusted to present values, the networth requirements set in 1982 for all license categories and increased the Allowable Range of Contract Cost (ARCC) as well as the corresponding track record requirements of Single Largest Project (SLP) for size ranges from Small B to Large B.

PCAB Resolution No. 001, Series of 2004, increased each stage of the adjustments in ARCC & SLP from one year to every two years to accommodate projects with durations exceeding one year. Both resolutions were published in newspapers of general circulation.

On 10 March 2004, the Government Procurement Policy Board (GPPB) adopted PCAB Resolution No. 001, series of 2004, in effect modifying the Table of Registration Particulars under Sec. 23.11.2.3 of the IRR-A of RA 9184. The GPPB also approved the implementation of the adjustment as follows;

- 1st Stage all projects advertised for bidding starting 01 July 2004 up to 30 June 2006
- 2nd Stage all projects advertised for bidding starting 01 July 2006 up to 30 June 2008
- 3rd Stage all projects advertised for bidding starting 01 July 2008 and thereafter

In view of this, PCAB has implemented the above adjustment on all applications approved for CFY 2004-2005 (i.e. July 1, 2004 to June 30, 2005).

PCAB, however, wishes to clarify that pursuant to the transitory provisions of BR 001, s. 2004, there will be size ranges issued under the old guidelines which remain valid after July 1, 2004 and up to expiration of previous registration. Size ranges based on adjusted SLPs are marked with asterisks for the information of tendering agencies. Tendering agencies are also encouraged to validate the size ranges of contractors submitting Temporary Certificates of Renewal with PCAB by email pcab@info.com.ph> or thru fax no. 895-4220.

BOARD RESOLUTION NO. 001 SERIES OF 2004

The Board discussed the implications of the adjustments on the allowable ranges of contract costs (ARCC) and the corresponding track record requirements (single largest project or SLP completed) under PCAB Resolution No. 949, s. 2003, and noted that a yearly upward adjustment of SLPs and ARCCs may be too stringent considering that projects may take more than one (1) year to complete and that a lot of government contractors would be unable to maintain their size ranges thus limiting the number of eligible bldders for medium & large projects to only a few.

After due deliberations, the Board RESOLVES to provide for a 2-year implementation period for each stage of the adjustment process, and clarifying the ranges of SLP requirements as follows:

The Board further **RESOLVES** to adopt the following transitory guidelines for the implementation of the above adjustments:

- The above adjustments in minimum track record requirements per size range with allowable ranges of contract cost shall be applied to all types of applications for registration for government projects (new registration, upgrading of size range, additional project kinds and applications for re-registration) filed starting 01 July 2004;
- 2. Registration particulars with validity dates extending beyond 01 July 2004 shall remain valid with the same registration particulars reflected therein until expiration date; Provided that, the license is valid and that the licensee possesses the license category required for the corresponding registration size range/s.

BOARD RESOLUTION NO. 949 SERIES OF 2003

Pursuant to CIAP Board Resolution No. 9, s. 2003, directing the Philippine Contractors Accreditation Board (PCAB) to, among others, implement the adjusted minimum networth requirements for categorization starting Contracting Fiscal Year (CFY) 2004-2005, the Board RESOLVES, as follows:

1. To approve for implementation starting CFY 2004-2005 the following networth requirements for licensing:

- Par. 3 of Section 23.11.2 of the IRR of RA9184 allows Small and Small B contractors without similar experience to bid only for contracts not more than fifty percent (50%) of the allowable range of contract cost of their respective size ranges.
- 3. To review and update the above adjustments when necessary or at least every five (5) years based on the Consumer Price Index or the purchasing power of the peso; and
- 4. To promulgate the Implementing Guidelines for the above adjustments as follows:
 - 4.1 Scope
 - These guidelines shall apply to all new, renewal and upgrading PCAB license & registration applications for CFY 2004-2005 and onwards.
 - 4.2 Renewing applicants not meeting the adjusted minimum networth requirement of their existing categories may take any or both of the following options, if applicable:
 - Additional investment/capital infusion

Supporting documents:

- a. Audited financial statements reflecting the additional investment/ capital infusion;
- b. In case of partnerships or corporations, amended articles of partnership/ incorporation increasing the authorized capitalization, if applicable, and updated list of stockholders, their nationalities and shareholdings;
- c. Certified true copies of documents showing the existence/ownership of newly acquired assets:
 - bank certification/statement of cash in bank account duly certified by the bank manager;

- ii. deeds of sale, invoices, and receipts of purchase of construction and transportation equipment;
- iii. LTO certificate of registration and current official receipt of registration of transportation/delivery equipment in the name of the applicant/licensee; and
- Deeds of sale, transfer certificates of title and tax declaration of real properties (land and building).

4.2.2 Appraisal of real properties, plants, machines and equipment

Supporting documents:

- a. Latest audited financial statements incorporating the said increase in value of assets due to appraisal and appraisal capital; and
- b. Independent appraiser's report.
- 4.3 Renewing applicants are required to file their renewal applications in accordance with the staggered renewal filing schedule based on the last digit of their respective license numbers as follows:

4 and 5	April -
6 and 7	May
8 and 9	June

- 4.4 Renewing applicants meeting the adjusted minimum networth of their respective categories need not submit the supporting documents in paragraphs 4.2.1 and 4.2.2 when the following conditions are met:
 - 4.4.1 The renewal application was filed within the above staggered renewal filing schedule;
 - 4.4.2 The increase in networth as of December 31, 2003 (as reflected in the applicant's audited financial statements duly filed with the BIR) does not exceed 25% of the applicant's networth as of December 31, 2002, or 20% of the networth as of the latest AFS submitted to PCAB for any upgrading application filed in 2003; and
 - 4.4.3 The applicant does not have any previous case for which license denial, suspension, or revocation was imposed by PCAB, and/or any pending case with the PCAB at the time of filing of its renewal application.

If any of the above conditions is not met, the applicant shall be required to substantiate additional investment/capital infusion and/or increase in asset values due to reappraisal with appropriate supporting documents in 4.2.1 and 4.2.2 above.

- 4.5 Supporting documents not certified by the issuing parties and/or with signs of tampering/alteration shall be subjected to independent verification by PCAB.
- 4.6 Renewing applicants failing to meet the adjusted minimum networth will be issued a renewal certificate with the appropriate highest sustainable category.
- 4.7 The above Implementing Guidelines and subsequent amendments/revisions thereto, shall also apply to the second and third phases of the adjustments for CFYs 2005-2006 & 2006-2007.
- 5. This resolution shall take effect immediately upon publication in a newspaper of general circulation.
