## 20<sup>TH</sup> WORLD COUNCIL FOR CURRICULUM AND INSTRUCTION NATIONAL CONVENTION

- 1. The World Council for Curriculum and Instruction (WCCI) will hold its 20<sup>th</sup> National Convention on November 4-5, 2004 at the Manila Pavilion, United Nations Avenue, Ermita, Manila with the theme "Educating for a World View: Focus on Globalizing Curriculum and Instruction".
- 2. The convention aims to:
  - increase awareness on concepts/ideas/trends/issues on Globalizing Curriculum and Instruction;
