2004 NATIONAL DAY OF YOUTH

To: Regional Directors
Schools Division/City Superintendent
Heads, Public and Private Secondary Schools

1. The National Youth Commission (NYC), the Department of Education-Center for Students and Co-Curricular Affairs (DepED-CSCA) and the Kabataang Sama-Samang Maglilingkod, Inc. (KASAMA) in partnership with the Businessworks, Inc. will spearhead the Annual National Day of Youth (NDY) on December 1-4, 2004 at the DepED-Ecotech Center, Lahug, Cebu City.
2. With the theme *"In Search for Filipino Youth Identity"*, the National Day of Youth is a part of a weeklong celebration of the *"Linggo ng Kabataan"* held every December of every year. This activity will give emphasis on positive values in the light of the various problems, issues, and concerns confronting the youth such as drug addiction and smoking, among others. Likewise, this event aims to promote among the youth the values of good citizenship, leadership, family unity, education and active participation in school and community activities.
3. The core event of the National Day of Youth will be interactive values appreciation and development training, team-building and organizational development session. The NDY will be participated by student government officers, school clubs, Boy Scouts and Girl Scouts, Campus Journalists, Student Technologists and Entrepreneurs of the Philippines (STEP), the Youth Entrepreneurship and Cooperativism in Schools (YECS) and other youth organizations and teacher-advisers/chaperones from different schools of the country.
4. Student-participants to the NDY shall be given enough time to prepare for the quizzes and other examinations which they might have missed during the conduct of the conference. In the same manner, student-participants shall be allowed reasonable time to comply with the other requirements of the different subject-areas.
5. A registration fee of Three Thousand Four Hundred Pesos (PhP 3,400.00) per participant shall be charged against local school board funds, PTCA funds or other funds appropriate for the purpose. The registration fee shall cover food and accommodation from dinner of Day 0 to breakfast of Day 4, kits, certificates, bags, t-shirts, speakers' honoraria and other incidental expenses of the program.
6. Members of the DepED-National Organizing Committee and Secretariat are authorized to travel three (3) days before the start of the National Day of Youth. Enclosed herewith are the members of the National Organizing Committee and Secretariat of the NDY.
