## NATIONAL ORIENTATION WORKSHOP ON THE IMPLEMENTATION OF THE DEPED ORDER NO. 51, s. 2004, PRESCRIBING NATIONAL STANDARD CURRICULUM FOR MADRASAH EDUCATION

The Department of Education in collaboration with UNICEF will hold a one-day National Orientation Workshop on the implementation of the DepED Order No. 51, s. 2004, prescribing National Standard Curriculum for Elementary Public Schools and Private Madaris on December 16, 2004, at Apo View Hotel, Davao City. The workshop shall be the avenue for the participants to discuss relevant issues, potential problems, and other concerns regarding the implementation of Madaris curriculum.

The participants in this orientation workshop are representatives from DepED ARMM, DepED Central Office, all Regional Directors, selected Schools Division Superintendents of field offices with substantial number of Muslim pupils. Regional Directors shall identify the Schools Division Superintendents who shall attend the workshop based on the number of slots per region as shown in Annex A. But DepEd-ARMM, Region IX, XI and XII, all the School Division Superintendents are expected to attend the workshop. Potential problems relative to its implementation that can be perceived by the participants shall be discussed and addressed in the workshop.

Transportation and other allowable expenses of representatives from DepED Central Office and other agencies, including board and lodging of all participants shall be charged against UNICEF funds subject to existing accounting and auditing rules and regulations. Transportation and other expenses of Regional and field office participants shall be charged against local funds.
