2005 PRIVATE SCHOOL HEALTH OFFICERS ASSOCIATION (PSHOA), INC. SILVER ANNIVERSARY AND ANNUAL CONVENTION

- 1. The Private School Health Officers' Association (PSHOA), Inc. announces the holding of its Silver Anniversary and Annual Convention on April 8, 2005 from 7:00 a.m. to 10:00 p.m. at the Harana Ballroom, Hyatt Regency Manila, 2702 Roxas Blvd., Pasay City with the grand theme "PSHOA at 25, **S**-olidifying I-ts L-asting **V**-ision to **E**-nrich its **R**-anks!".
- 2. The objectives of the convention are to:

Registration fees and other expenses incident to the attendance of the participants to this convention shall be charged against the funds of their respective institutions.
