TRAINING WORKSHOP ON STRATEGIC INTERVENTIONS FOR SUCCESSFUL LEARNING

1. In its continuing effort to raise the quality of education in the country, the Bureau of Secondary Education (BSE), this Department shall conduct a two-cluster training workshop on Strategic Interventions for Successful Learning on the following dates and venues:

Cluster 1 – Luzon	Regions I – V,	April 18 – 22,	Legenda Hotel,
Cluster 2 – Visayas	CAR and NCR Regions VI – XIII	2005	Olongapo City
and Mindanao	and ARMM	May 2 – 6, 2005	Grand MenSeng Hotel, Davao City

- 2. The training workshop aims to:
 - a. enhance teachers' skill in test analysis and interpretation; and
 - b. capacitate them in developing various intervention materials for remediation and enrichment of learning.
- The participants from each region shall include the following:
 - a. two (2) teachers each from every learning area;
 - b. Regional Supervisors of the 8 learning areas; and
 - c. Secondary Education Division Chief or Assistant Chief.
- 4. The participants are requested to bring with them the following:
 - a. scored test papers with the corresponding Table of Specifications (TOS), of one class/section in their particular area of specialization. These may be the High School Readiness Test (HRST), periodic or division and regional achievement tests;
 - b. calculator;
 - c. reference materials or textbooks in their learning areas; and
 - d. a report of the Regional Supervisor on the regional implementation of the Bridge Program.
- 5. The first meal of Cluster 1 participants shall be dinner of April 17 and the last meal shall be lunch of April 22. For Cluster 2, first meal shall be dinner of May 1 and last meal shall be lunch of May 6, 2005.

- 6. The board and lodging of participants, BSE staff, other DepED personnel and resource speakers including honoraria and transportation expenses of training staff and resource persons shall be charged to BSE funds. Transportation and other incidental expenses of participants relative to their travel shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.
