## NATIONWIDE MOS ICT LITERACY TRAINING OF PUBLIC SECONDARY SCHOOL TEACHERS

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Secondary Schools

1. The Department of Education (DepED) through the Bureau of Secondary Education (BSE), in cooperation with the Partners in Learning (PIL), shall conduct a nationwide ICT Literacy Training of Public Secondary School Teachers on MS Office Specialist (MOS) between April 25, 2005 and May 20, 2005 at the designated computer laboratories of the PIL partner universities or colleges assigned to the schools. The schedules of the training are as follows:

2 <sup>nd</sup> Batch	May 2-6, 2005					
3 <sup>rd</sup> Batch	May 9-13, 2005					
4 <sup>th</sup> Batch	May 16-20, 2005					

- 2. The activity aims to: (a) upgrade the ICT literacy skills of the teachers specifically on MOS; (b) update teachers on the use of the technology in classroom management; and (c) enhance the ICT potentials of the teachers on the use of ICT in teaching and learning.
- 3. The participants to this nationwide activity are the public secondary school teachers of computer recipient schools under the DepED Computerization Program, PCs for Public Schools Batches 1 and 2, etc.
- 4. Travel expenses of the participants shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
- 5. The template for sign-up sheet/s for teachers (copy enclosed) may be accomplished by the school head so that Philippine Business for Social Progress (PBSP) could match the participants with the nearest training partner. The said accomplished sign-up sheet/s may be sent by telefax (02) 527-3743 (c/o Ms. Girlie Corona or Ms. Grace Palapus) to Philippine Business for Social Progress (PBSP), Intramuros, Manila not later than April 14, 2005.
