CREATION OF TEACHER EDUCATION AND DEVELOPMENT PROGRAM (TEDP)
TECHNICAL WORKING GROUP

- 1. To operationalize the priority thrust of DepED to improve the quality of teachers, this Department in collaboration with various partner agencies has already initiated series of discussions on the above-subject program with different stakeholders. The Program which is a package of policy reforms that has been progressively developed since 1997 has evolved into a two-track package of policy reforms and program/project investments.
- 2. Given the need to formulate the TEDP document which will spell out the specific policy reforms and programs/projects called for in the enclosed Teacher Education and Development Map, an Inter-Agency TEDP Technical Working Group (TEDP TWG) is hereby created for this purpose. The TEDP TWG shall report to the DepED Program Committee (PROGCOM) who shall serve as the TEDP Advisory Committee. The Chair of the PROGCOM shall call upon any bureau, center or office for assistance as it may need to assist the TEDP TWG perform its function.
