SEMINAR-WORKSHOP ON THE PREVENTION OF VIOLENCE AGAINST WOMEN (VAW) (Prevention of Sexual Harassment in the Workplace)

Regional Directors To: **Bureau Directors** Directors of Services, Centers and Heads of Units Schools Division/City Superintendents

- The Department of Education (DepED) is one of the fifteen (15) agencies with Violence Against Women (VAW) related mandates. Recognizing these mandates, the Staff Development Division-Human Resource Development Service (SDD-HRDS) will conduct a 4-day Seminar-Workshop on the Prevention of Violence Against Women (VAW) for nonteaching personnel. This is also in response to Republic Act No. 7192, "Women in Development and Nation Building Act", An Act Promoting the Integration of Women as Full and Equal Partners of Men in Development and Nation Building.
- The objectives of the program are to: 2.
 - a. raise gender awareness among the participants enabling them to be more committed and responsive to individual clients;
 - b. clarify various VAW concepts;
 - c. identify the different forms of violence against women, including sexual harassment in the workplace, and how to prevent them; and
 - d. identify ways on how to handle VAW issues/cases with emphasis on referral/reporting systems.
- Refer to enclosure for the schedules, venues, number of participants per region and 3. divisions.
- Travel expenses and per diem (before and after the training) of participants are chargeable against local funds, while board and lodging of participants and staff/facilitators and travel expenses, per diem (before and after the training), extra duty allowance of the project staff and facilitators and honorarium of external resource speakers and other incidental expenses of the training are chargeable against Special Program Funds subject to the usual accounting and auditing rules and regulations.
